Dear Mr. Collins,

Per Chapter 7. Article IV (Storm Water Management) of the Village Code of Northfield, any new development or series of developments covering an area of 1,000 square feet or more shall provide storm water deter ion to accommodate storm water run-off in accordance with the requirements of the Village Code.

Any development which would result in less than 1,000 square feet of additional impervious ground coverage shall be required to contribute to the Village a monetary amount in lieu of storm water detention.

We have reviewed the submitted plan received May 24, 2019 with revisions noted and approved on June 12, 2019 for the replacement and ividening of the asphalt driveway, front brick walkway replacement and realignment and the rear patio paver replacement and expansion. It was determined that the increase in impervious ground coverage to be 276 square feet. The fee for the 276 square feet at \$4.50 per square foot is \$1,242.00 plus a \$100.00 recording fee for a total of \$1,342.00.

The addition of the 276 square feet of impervious ground of verage brings the total on this property to 48.7 percent which is just under the maximum 50 percent lot coverage allowed by the Village Code.

By the current property owners signing this document and it being recorded, current and future owners will be placed on notice that additional impervious lot coverage on this property will be limited to 90 square feet.
