NOTICE OF APPOINTMENT OF SUCCESSOR TRUSTEE

Better Housing Foundation, Shoreline Portfolio Project

On July 1, 2016, the Illinois Finance Authority (the "Issuer") issued a Trust Indenture for certain Multifamily Revenue Bonds in the aggregate amount of \$13,560,000.00 between Wilmington Trust, National Association (the "Prior Trustee") to Lindran Properties LLC whose sole Member is the Better Housing Foundation (the "Borrower"). Wilmington Trust, National Association (the "Prior Trustee") served as the Trustee for the Indenture. The Indenture, related bonds and security documents are commonly known as the **Better Housing Foundation, Shoreline Portfolio Project**.

On or about June 10, 2019, UMB Bank, N.A., accepted appointment as successor trustee to, Wilmington Trust, National Association, as trustee, under that certain Indenture dated July 1, 2016, between the Illinois Finance Authority, Lindran Properties LLC as borrower and Wilmington Trust, National Association as Trustee for the bond portfolio known as Better Housing Foundation Shoreline Portfolio Project.
