

NOTICE is hereby given of a lien against the property and rights to property, both real and personal, of the defendant named below. Pursuant to 18 U.S.C. § 3613,



a fine or restitution imposed in a case brought under Title 18 of the United States Code is a lien in favor of the United States upon all property and rights to property, both real and or personal, belonging to the defendant. Pursuant to 18 U.S.C. § 3615(i), this notice of lien shall be considered the equivalent of a notice of lien for unpaid federal taxes (under the Internal Revenue Code of 1986). Pursuant to 18 U.S.C. § 3613(d), this notice of lien shall be considered a notice of lien for taxes payable to the United States for the purpose of any state or local law providing for the filing of a ratice of a tax lien (and the recorder of deeds should charge the United States fees set out in your state's version of § 5 of the Uniform Federal Lien Registration Act). The lien arises on the entry of judgment and continues until the liability is satisfied, remitted, or set aside, or until it becomes unenforceable.
