AGREED DEFAULT ORDER

THIS CAUSE COMING TO BE HEARD on the Motion of THE BANK OF NEW YORK MELLON f/k/a THE BANK OF NEW YORK as Trustee for HOME EQUITY LOAN TRUST 2007-FRE1, the mortgagee on the property located at 7227 South Claremont Avenue, Chicago, Il 60636, the Court having jurisdiction and being duly advised in the premises, and due notice having been given to the parties entitled thereto;

IT IS HEREBY CROERED:

- 1. The Automatic Stay is hereby extended as to all creditors.
- 2.
