#### LEASE TERMINATION AGREEMENT


THIS TERMINATION AGREEMENT is entered into and is effective as of the 30 day of August, 2019 by and between SV Care, LLC, a Delaware limited liability company ("Lessee") and SV Chicago, LLC, a Delaware limited liability company ("Lessor"),

WHEREAS, Lessee and Lessor emered into a Lease for a term of years commencing June 27, 2012 (together with any amendments, if any, collectively the "Lease") for the property known as 3311 Sovan Michigan Avenue, Chicago, Illinois 60616, relating to property legally described in Exhibit A hereto (the "Property");

WHEREAS, it is a further requirement of Section 6.1 of the Plan of Liquidation that the release and termination of any interest of Lessee under the Lease in and to the

Property as a result of such rejection be evidenced by a recordable instrument, effective as of such effective date of the Plan of Liquidation; and

WHEREAS, such effective date of the Plan of Liquidation has occurred as of the date set forth above.

THEREFORE, in consideration of the preceding Recitals, the Lessee and the Lessor agree that, effective as of date set forth above, the Lease is terminated, and all rights and interests of the Lessee relative to the Property, including the right of TODO OF COUNTY CLOTH'S OFFICE possession, have been released, terminated, and otherwise extinguished.
