#### MODIFICATION AND EXTENSION AGREEMENT

THIS AGREEMENT made as of this 27th day of September, 2019 between REPUBLIC BANK OF CHICAGO, an Illinois banking corporation, successor in interest to National Bank of Commerce hereinafter called Lender, and EDWARD F. HORNBOSTEL and VERONICA HORNBOSTEL, Borrower under the National Bank of CHICAGO TITLE LAND TRUST COMPANY, AS SUCESSOR TO NORTH STAR TRUST COMPANY AS SUCCESSOR TO NATIONAL BANK OF COMMERCE, NOT PERSONALLY BUT AS TRUSTED ON BEHALF OF NATIONAL BANK OF COMMERCE TRUST # 9923 U/T/A DATED AUGUST 12. 1999 the Owner of the property hereinafter called Second Party, WITNESSETH:

THAT WHEREAS, Lender is the owner of a certain Note in the amount of \$300,000.00 dated February 6, 2004, together with all rene vals, extensions, modifications, refinancings, consolidations and substitutions thereof secured either in while or in part by a Mortgage and Assignment of Rents recorded as Document Nos. 0406235100 and 0406235101 respectively, covering the real estate described below:

WHEREAS, the parties hereto wish to modify the terms of raid Note and Mortgage by extending the maturity thereof and recalculating the monthly payments there which based upon a 7 year amortization and as otherwise set forth herein:

NOW THEREFORE, in consideration of ONE DOLLAR (\$1.00), the covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. As of the date hereof, the amount of the principal indebtedness is ONE HUNDREI NIN ETEEN THOUSAND ONE HUNDRED THIRTY TWO AND 87/100 DOLLARS (\$119,132.87).
- 2. The maturity date of the Note and Mortgage hereinbefore described is hereby extended from lune 1, 2019 to October 1, 2024.
- 3. That the Interest Rate of such Note shall remain the existing fixed interest rate of 5.00%.
  - Actual interest shall be calculated on the basis of a 365/360 day year; which is to say that by applying the ratio of the rate of interest charged over a year of 360 days, multiplied by the outstanding principal balance, multiplied by the actual number of days the principal balance is outstanding. All sums received by the Lender shall be applied first to costs then accrued interest and then to principal.
- 4. The new monthly payment will be in monthly principal and interest in the amount of \$1,716.43 each beginning on November 1, 2019 and continuing on the 1<sup>st</sup> day of each and every month thereafter, except that all sums due, if not sooner paid, shall be due and payable on October 1, 2024.

- 5. Cross-Collateralization: In addition to the Note, the Mortgage shall secure all obligations, debts and liabilities, plus interest thereon, of Second Party, or any one or more of them, to Lender as well as all claims by Lender against Second Party or any one or more of them, to Lender whether now existing or hereafter arising, whether related or unrelated to the purpose of the Note, whether voluntary or otherwise, whether due or not due, direct or indirect, determined or undetermined, absolute or contingent, liquidated or unliquidated, whether Second Party may be liable individually or jointly with others, whether obligated as guarantor, surety, accommodation party or otherwise, and whether recovery upon such amounts may be or hereafter may become barred by any statute of limitations, and whether the obligation to repay such amounts may be or hereafter may become otherwise unenforceable (the "Other Indebtedness"). The Other Indebtedness shall include that certain Note dated October 23, 2002 in the amount of \$392,000.00.
- 6. Cross Default: If Second Party is in default under the Other Indebtedness or under any document, instrument or agreement securing the same, it shall be deemed a default under the Note and Mortgage. If Second Party shall be in default under the Note, Mortgage or any document, instrument of agreement securing the same, it shall be deemed a default under the Other Indebtedness and under any nor page, document, instrument or agreement securing the same.
- This agreement is subject to Second Party paying Lender a flood determination fee of \$25.00 and loan documents ion fee of \$475.00. Total due with Modification is \$500.00.

Second Party warrants and certifies that the indebtedness evidenced by the Note is a valid and subsisting debt of the Borrower and in all respects free from all defenses, setoffs and counterclaims both in law and equity, as is the lien of the Mortgage.

In all other respects, the Note hereinbefore described and all mortgages, documents and/or instruments securing the same shall remain unchanged and in full force and effect.

Notwithstanding the foregoing, Second Party expressly waives any defenses, which it now has or may have or assert. Furthermore, in order to induce Bank to enter into this agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Second Party does hereby release, remise and forever discharge Bank of and from any and all setoffs, claims, counterclaims, demands, causes, causes of action, suits and/or judgments which it now has or may have against Bank including but not limited to matter arising out of the Note and/or any do ument, instrument or agreement securing the same or arising out of any banking relationship existing between the parties.
