In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- As of 06/01/2019, the amount payable under the Note and the Security Instrument (the "New Principal Balance") is U.S. \$175,301.50 consisting of the unpaid amount(s) loaned to Customer by Lender plus any interest other amounts capitalized.
- 2. Customer promises to pay the Unpaid Principal Balance, plus interest, to the order of Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 4.625%, from 06/01/2019. Customer promises to make monthly payments of principal and interest of U.S. \$802.23, beginning on the 07/01/2019, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full. The yearly rate of 4.625% will remain in effect until principal and interest are paid in full. The new monthly payment amount does not include any amounts owed for escrow. Customer may refer to the monthly billing statement for the escrow amount owed. If on 06/01/2059 (the "Maturity Date"), Customer still owes amounts under the Note and

If all or Ray part of the Property or any interest in the Property is sold or transferred (or if Customer is not a natural person and a beneficial interest in Customer is sold or transferred) without Lender's prior written consent, Lender may require immediate payment in full of all sums secured by the Security Instrument.


