Recitals

Mortgagor has requested that Mortgagee make the Loan (as hereinafter defined) to Mortgagor. As a condition precedent of making the Loan, Mortgagee has required that Mortgagor execute and deliver this Mortgage, Assignment of Rents, Security Agreement and Fixture Filing to Mortgagee.

Grants and Agreements

Now, therefore, in order to induce a fortgages to make the Loan to Mortgagor, Mortgagor agrees as follows:

Article I Defi de exa

As used in this Mortgage, the terms defined in the Preamble hereto shall have the respective meanings specified therein, and the following additional terms shall have the meanings specified:

Accessories means all fixtures, equipment, systems, machinary, furniture, furnishings, appliances, inventory, goods, building and construction materials, supplies and off or articles of personal property, of every kind and character, tangible and intangible (including software enter 4ed therein), now owned or hereafter acquired by Mortgagor, which are now or hereafter attached to or situated in, on or about the Land or Improvements, or used in or necessary to the complete and proper planning, development, use, occupancy or operation thereof, or acquired (whether delivered to the Land or storet elsewhere) for use or installation in or on the Land or improvements, and all Additions to the foregoing, all of which are hereby declared to be permanent accessions to the Land.

Additions means any and all alterations, additions, accessions and improvements to property, substitutions therefor, and renewals and replacements thereof.

Casualty means any act or occurrence of any kind or nature that results in damage, loss or destruction to the Property.

Claim: means any liability, suit, action, claim, demand, loss, expense, penalty, fine, judgment or other cost of any kind or nature whatsoever, including fees, costs and expenses of attorneys, consultants, contractors and experts.

Condemnation means any taking of title to, use of, or any other interest in the Property under the exercise of the power of condemnation or eminent domain, whether temporarily or permanently, by any Governmental Authority or by any other Person acting under or for the benefit of a Governmental Authority.

Condemnation Awards means any and all judgments, awards of damages (including severance and consequential damages), payments, proceeds, settlements, amounts paid for a taking in lieu of Condemnation, or other compensation heretofore or hereafter made, including interest thereon, and the right to receive the same, as a result of, or in connection with, any Condemnation or threatened Condemnation.

Corange of Sale means any contract for the sale of all or any part of the Property or any interest therein, whether now in existence or hereafter executed.

Default means an event or circumstance which, with the giving of Notice or lapse of time, or both, would constitute a Breat of Default under the provisions of this Mortgage.

Design and Construct v. Documents means, collectively: (a) all contracts for services to be rendered, work to be performed or reaterials to be supplied in the development of the Land or the construction or repair of Improvements, including all agreements with architects, engineers or contractors for such services, work or materials; (b) all plans, drawings and specifications for the development of the Land or the construction or repair of Improvements; (c) all permits, licenses, variances and other rights or approvals issued by or obtained from any Governmental Authority or other Person in connection with the development of the Land or the construction or repair of Improvements; and (d) all amendments of or supplements to any of the foregoing.

Expenses means all fees, charges, costs and expenses of any nature whatsoever incurred at any time and from time to time (whether before or after an Event of Default) by Mortgagee in making, funding, administering or modifying the Loan, in negotiating or entering into any "workout" of the Loan, or in exercising or enforcing any rights, powers and remedies provided in this Mortgage or any of the

other Loan Documents, including attorneys' fees, court costs, receiver's fees, management fees and costs incurred in the repair, maintenance and operation of, or taking possession of, or selling, the Property.

Future Advances means any loss of money from Mortgagee to Mortgagor made within twenty (20) years from the date hereof. The total amount of such loss or loss may increase or decrease from time to time, but the total unpaid aggregate balance secured by this Mortgage at any one time shall not exceed \$222400, plus interest thereon, and any disbursements made for the payment of the Property Assessments (whether taxes, levies or otherwise), insurance, or other liens on the Property, with interest on such disbursements. Conveyances and Sea ity Interests. In order to secure the prompt payment and performance of the Obligations, Mortgay or: (a) grants, bargains, sells, aliens, remises, releases, assigns, mortgages, hypothecates, deposits, piedges, one over, confirms, warrants and conveys the Real Property unto Mortgagee, all estate, right, title and interest of Mortgagor in and to the Real Property, whether now owned or held or hereafter acquired by Mortgagos, to have and hold the Real Property unto Mortgages, its. successors and assigns forever; and to hold the Real Property unto Mortgagee in fee simple forever; provided that Mortgagor may retain possession of the Par Property until the occurrence of an Event of Default; (b) grants to Mortgagee a security interest in the Propagatty; (c) assigns to Mortgagee, and grants to Mortgagee a security interest in, all Condemnation Awards and all Insurance Proceeds (subject to the terms and conditions of any existing Leases); and (d) assigns to Mortgagee, and grants to Mortgagee a security interest in, all of Mortgagor's right, title and interest in, but my any of Mortgagor's obligations or lishilities under, all Design and Construction Documents, all Control of Sale and all Refinancing Commitments. Section 2.2 Absolute Assistment of Leases and Rents. In consideration of the making of the Loan by Mortgagee to Mortgager, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Mortgager absolutely and unconditionally assigns the Leases and Rents to Mortgagee. This assignment is, and is intended to be, an unconditional, absolute and present assignment from Mortgager to Mortgagee of all of Mortgager's right, title and interest in and to the Leases and the Rents and not an assignment in the nature of a pledge of the Leases and Rents or the mere grant of a security interest therein. Article III Representations and Warranties

OFFICE Mortgagor makes the following representations and warranties to Mortgagee:

Title to Real Property. Mortgagor: (a) owns fee simple title to the Real Property; (b) owns all of the beneficial and equitable interest in and to the Real Property; and (c) is lawfully seized and possessed of the Real Property. workmen's compensation insurance, and physical damage insurance;

- (ii) insurance against loss by fire, risks covered by the so-called extended coverage endorsement, and other risks as Mortgagee may reasonably require, in amounts equal to not less than one hundred percent (100%) of the full replacement value of the Property;
- (iii) public liability insurance against bodily injury and property damage with such limits as Mortgagee may require;
- (iv) steam boiler, machinery, and other insurance of the types and in amounts as Mortgagee may require, but in any event not less than customarily carried by persons owning or operating like properties; and
 - if the Property are located in an area that has been identified by the United States Department of Housing and Urban Development as an area having special flood hazards and if the sale of flood insurance has been rade available under the National Flood Insurance Act of 1968 or other applicable law or regulation, flood insurance in an amount at least equal to the replacement cost of any improvements on the Property or to the maximatry limit of coverage made available with respect to the particular type of property under the National Flood Insurance Act of 1968 or such other applicable law or regulation, whichever is less.
- (c) All insurance policies required hereby (Policies) shall:
 - (i) contain an endorsement of a preement by the insurer that any loss shall be payable in accordance with the Policy notwithstanding any act or negligence of Mortgagor which might otherwise result in forfeiture of said insurance, and the further agreement of the insurer waiving all rights of set off, counterclaim or deductions of instruments.
 - (ii) provide that the amount payable for any ass shall not be reduced by reason of co-insurance;
 - (iii) be issued by companies and in amounts in each commany reasonably satisfactory to Mortgagee;
 - (iv) name Mortgagor and Mortgagoe as insureds, as their respective interests may appear, and have attached thereto a mortgagoe's loss payable endorsement for the benefit of Mortgagoe in form satisfactory to Mortgagoe.
- (d) Mortgagor shall furnish Mortgagee with certificates of insurance in form and substance satisfactory to Mortgagee. Not less than five (5) days prior to the date the premium is due for each Policy, Mortgagor shall furnish Mortgagee with evidence satisfactory to Mortgagee of the payment of the premium. Not less than thirty (30) days prior to the expiration of any certificate of insurance required to be delivered hereunder, Mortgagor shall furnish Mortgagee with a replacement certificate and/or other evidence satisfactory to Mortgagee of the extension and continuance in force of the insurance coverage. Each Policy shall contain a provision that such policy will not be cancelled, amended or reduced in amount or scope without at least thirty (30) days' prior written notice to Mortgagee.

- (e) If requested by Mortgagee, order to provide moneys for the payment of the Property Assessments and the premiums on the Policies, Mortgager shall pay to Mortgagee on a monthly basis on such date(s) as Mortgagee shall require such amount as Mortgagee shall estimate will be required to accumulate, by the date thirty (30) days prior to the due date of the next annual installment of such Property Assessments and premiums, through substantially equal monthly payments by Mortgager to Mortgagee, amounts sufficient to pay such next annual Property Assessments and insurance premiums, Mortgagee shall hold all such payments in escrow, without interest unless required by law. Such amounts held in escrow shall be made available to Mortgagor for the payment of the Property Assessments and insurance premiums when due, or may be applied thereto directly by Mortgagee if it in its sole discretion so elects.
- Mortgagor shall give prompt Notice to Mortgagee of any Casualty or any Condemnation threatened Condemnation. Mortgagee is authorized, at its sole and absolute option, to commence, appearing and prosecute, in its own or in Mortgagor's name, any action or proceeding relating to any Condemnation Casualty, and to make proof of loss for and to settle or compromise any Claim in connection therewith. 14 such case, Mortgagee shall have the right to receive all Condemnation Awards and insurance Proceeds, and may deduct therefrom all of its Expenses. However, so long as no Event of Default has occurred and Morto and is diligently pursuing its rights and remedies with respect to a Claim, Mortgagee will obtain Mortgagor's witten consent (which consent shall not be unreasonably withheld or delayed) before making proof of kes for or settling or compromising such Claim. Mortgagor agrees to diligently assert its rights and remedie. with respect to each Claim and to promptly pursue the settlement and compromise of each Claim subject to Mortgagee's approval, which approval shall not be unreasonably withheld or delayed. If, prior to the receipt by Mortgages of any Condemnation Award or Insurance Proceeds, the Property shall have then sold pursuant to the provisions of the Mortgage, Mortgagee shall have the right to receive such funds: (1) to the extent of any deficiency found to be due upon such sale with interest thereon (whether or not a deficiency judgment on the Mortgage shall have been sought or recovered or denied); and (ii) to the extern recessary to reimburse Mortgagee for its Expenses. If any Condemnation Awards or Insurance Proceeds are paid to Mortgagor, Mortgagor shall receive the same in trust for Mortgagee. Within ten (10) day's ofter Mortgagor's receipt of any Condemnation Awards or Insurance Proceeds, Mortgagor shall dehver such awards or proceeds to Mortgagee in the form in which they were received, together with any adorsements or documents that may be necessary to effectively negotiate or transfer the same to Mortgage a Mortgagor agrees to execute and deliver from time to time, upon the request of Mortgagee, such further instruments or documents as may be requested by Mortgagee to confirm the grant and assignment to Mortgage of any Condemnation Awards or Insurance Proceeds.
- (g) Net Proceeds must be utilized either for payment of the Obligations or for the restoration of the Property. Net Proceeds may be utilized for the restoration of the Property only if no Default shall exist and only if in the reasonable judgment of Mortgages: (i) there has been no material adverse change in the financial viability of the Improvements; (ii) the Net Proceeds, together with other funds deposited with Mortgages for that purpose, are sufficient to pay the cost of the restoration pursuant to a budget and plans and specifications approved by Mortgages, and (iii) the restoration can be completed prior to the final maturity of the Loan and prior to the date required by any permanent loan commitment or any purchase and sale agreement or by any Lease. Otherwise, Net Proceeds shall be utilized for payment of the Obligations.
- (h) If Net Proceeds are to be utilized for the restoration of the Property, the Net Proceeds, together with any other funds deposited with Mortgagee for that purpose, must be deposited in Mortgagor's Deposit Account, which shall be an interest-bearing account, with all accrued interest to become part of Mortgagor's deposit. Mortgagor agrees that it shall include all interest and earnings on any such deposit as its income (and, if Mortgagor is a partnership or other pass-through entity, the income

of its partners, members or beneficiaries, as the case may be), and shall be the owner of all funds on deposit in Mortgagor's Deposit Account for federal and applicable state and local tax purposes. Mortgagee shall have the exclusive right to manage and control all funds in Mortgagor's Deposit Account, but Mortgagee shall have no fiduciary duty with respect to such funds. Mortgagee will advance the deposited funds from time to time to Mortgagor for the payment of costs of restoration of the Property upon presentation of evidence acceptable to Mortgagee that such restoration has been completed satisfactorily and lien-free. Any account fees and charges may be deducted from the balance, if any in Mortgagor's Deposit Account. Mortgagor grants to Mortgagee a security interest in Mortgagor's Deposit Account and all funds hereafter deposited to such deposit account, and any proceeds thereof, as security for the Obligations. Such security interest shall be governed by the Uniform Commercial Code of the State, and Nortgagee shall have available to it all of the rights and remedies available to a secured party thereunder. Mortgagor's Deposit Account may be established and held in such name or names as Mortgagee and deem appropriate, including in the name of Mortgagee. Mortgager hereby constitutes and appoints have see and any officer or agent of Mortgagee its true and lawful attorneys-in-fact with full power of substitution to open the Mortgagor's Deposit Account and to do any and every act that Mortgagor might do on its own behalf to fulfill the terms of this Section. To the extent permitted by Law. Mortgagor hereby ratifies all that said attorneys shall lawfully do or cause to be done by virtue hereof. It is understood and agreed that this power of attorney, which shall be deemed to be a power coupled with an interest, cannot be revoked.

Permitted Constasts. Mortgagor shall not be required to pay any of the Property Section 4.3 Assessments, or to comply with any Law, so long as Mortgagor shall in good faith, and at its cost and expense, contests the amount or validity thereof, or take other appropriate action with respect thereto. in good faith and in an appropriate manner or by appropriate proceedings; provided that: (a) such proceedings operate to prevent the collection of, or on a realization upon, such Property Assessments or enforcement of the Law so contested; (b) there will be no rale, forfeiture or loss of the Property during the contest; (c) Mortgagee is not subjected to any Claim 7.5 ? result of such contest; and (d) Mortgagor provides assurances satisfactory to Mortgagee (including the establishment of an appropriate reserve account with Mortgagee) of its ability to pay such Property Assessments or comply with such Law in the event Mortgagor is unsuccessful in its contest. Each such contest shall be promptly prosecuted to final conclusion or settlement, and Mortgagor shall indemnify and save Mcc. agee harmless against all Claims in connection therewith. Promptly after the settlement or conclusion of social contest or action, Mortgagor shall comply with such Law and/or pay and discharge the amounts which shall be levied, assessed or imposed or determined to be payable, together with all penalties, fines, interest, costs and expenses in connection therewith.

Section 4.4 Compliance with Laws. Mortgagor will comply with and not violate, will cause to be complied with and not violated, all present and future Laws applicable to the Property and it use and operation. Mortgagor shall comply with all Laws and all orders, writs, injunctions, decrees and comands of any court or any Governmental Authority affecting Mortgagor or the Property. Mortgagor shall use all proceeds of the Loan for business purposes which are not in contravention of any Law or any Loan Document.

Section 4.5 <u>Maintenance and Repair of the Property</u>. Subject to the terms and conditions of any existing Leases, Mortgagor, at Mortgagor's sole expense, will: (a) keep and maintain Improvements and Accessories in good condition, working order and repair; and (b) make all necessary or appropriate repairs and Additions to Improvements and Accessories, so that each part of the Improvements and all of the Accessories shall at all times be in good condition and fit and proper for the respective purposes for which they were originally intended, erected, or installed.

Section 4.6 Additions to Security. All right, title and interest of Mortgagor in and to all

Improvements and Additions hereafter constructed or placed on the Property and in and to any Accessories hereafter acquired shall, without any further Mortgage, conveyance, assignment or other act by Mortgagor, become subject to the Lien of this Mortgage as fully and completely, and with the same effect, as though now owned by Mortgagor and specifically described in the granting clauses hereof. Mortgagor agrees, however, to execute and deliver to Mortgagee such further documents as may be required by the terms of the other Loan Documents.

Section 4.7 <u>Subrogation</u>. To the extent permitted by Law, Mortgagee shall be subrogated, notwithstanding its release of record, to any Lien now or hereafter existing on the Property to the extent that such Lien is paid or discharged by Mortgagee whether or not from the proceeds of the Loan. This Section and not be deemed or construed, however, to obligate Mortgagee to pay or discharge any Lien.

Section 4.8 Janes.

- (a) Mortgagor shall not enter into any Lease with respect to all or any portion of the Property without the prior written consent of Mortgagee.
- (b) Mor properly shall not be obligated to perform or discharge any obligation of Mortgagor under any Lease. The astigment of Leases provided for in this Mortgage in no manner places on Mortgagee any responsibility for: (i) the control, care, management or repair of the Property; (ii) the carrying out of any of the terms and conditions of the Leases; (iii) any waste committed on the Property, or (iv) any dangerous or defective condition of the Property (whether known or unknown).
- (c) No approval of any Let se by Mortgagee shall be for any purpose other than to protect Mortgagee's security and to preserve Mortgagee's rights under the Loan Documents, and no such approval shall result in a waiver of a Default or Event of Default.
- (d) In addition to all other obligations water this Mortgage, Mortgagor agrees to provide Mortgagee (within 10 business days of Mortgagee's request) (i) a full, complete and updated Certificate of Leases and Rent Roll in form and substance acceptable to Mortgagee, (ii) a copy of all Leases and (iii) such evidence as Mortgagee deems reasonably necessar, is show each respective tenant's payment of his/her/their obligations under such Lease.
- Section 4.9 Bankruntey. In the event the Mortgagor should seek protection under the U.S. Bankruptcy Code, or should Mortgagor be adjudicated a debtor thereunder, Mortgagor hereby consents to relief from the automatic stay pursuant to 11 USC 362(d) to allow Mortgages to proceed to aid obtain, a final judgment of foreclosure of this Mortgage, to complete a foreclosure sale pursuant there is no cause the issuance of a certificate of title pursuant thereto, and to otherwise take all such actions as Mortgages may elect in its sole discretion in pursuance of the other rights and remedies available to Mortgage in the case of a default under this Mortgage. Mortgagor hereby waives any protection under 11 U.S.C. 362(a).
- Section 4.10 <u>Indemnification</u>. Mortgager agrees to indemnify Mortgagee and to hold Mortgagee harmless from and against, and to defend Mortgagee by counsel approved by Mortgagee against, any and all Claims directly or indirectly arising out of or resulting from any transaction, act, omission, event or circumstance in any way connected with the Property or the Loan, including any Claim arising out of or resulting from: (a) any construction activity at the Property, including any defective workmanship or materials; (b) any failure by Mortgagor to comply with the requirements of any Laws or to comply with any agreement that applies or pertains to the Property, including any agreement with a broker or "finder" in connection with the Loan or other financing of the Property; (c) any failure by Mortgagor to observe

and perform any of the obligations imposed upon the landlord under the Leases; (d) any other Default or Event of Default hereunder or under any of the other Loan Documents; or (e) any assertion or allegation that Mortgagee is liable for any act or omission of Mortgagor or any other Person in connection with the ownership, financing, leasing, operation or sale of the Property; provided, however, that Mortgagor shall not be obligated to indemnify Mortgagee with respect to any Claim arising solely from the gross negligence or willful misconduct of Mortgagee. The agreements and indemnifications contained in this Section shall apply to Claims arising both before and after the repayment of the Loan and shall survive the repayment of the Loan, any foreclosure or deed, assignment or conveyance in lieu thereof and any other action by Mortgagee to enforce the rights and remedies of Mortgagee hereunder or under the other Loan Documents.

- Section 4.1! <u>Estopoel Certificates</u>. Within ten (10) days after any request by Mortgagee or a proposed assert or purchaser of the Loan or any interest therein, Mortgagor shall certify in writing to Mortgagor claims on right of defense or setoff to the payment or performance of any of the Obligations, and if Mortgagor claims my such right of defense or setoff, Mortgagor shall give a detailed written description of such claims right.
- Section 4.12 Taxes: Tax Receipt. Mortgagor shall pay and discharge all Taxes prior to the date on which penalties are attached then to unless and to the extent only that such Taxes are contested in accordance with the terms of the Mortgagor fails, following demand, to provide Mortgagoe the tax receipts required under the Mortgago vithout limiting any other remedies available to Mortgagoe, Mortgagoe may, at Mortgagor's sole expense, obtain and enter into a tax services contract with respect to the Property with a tax reporting agency satisfact sy to Mortgagoe.
- Section 4.13 Mortgagee's Rights to Pav and Penglip. If, after any required notice, Mortgagor fails to promptly pay or perform any of the Obligations vindin any applicable grace or cure periods, Mortgagee, without Notice to or demand upon Mortgage's, and without waiving or releasing any Obligation or Default, may (but shall be under no obligation to at any time thereafter make such payment or perform such act for the account and at the expense of Mortgagee. Mortgagee may enter upon the Property for that purpose and take all action thereon as Mortgagee complete necessary or appropriate.
- Section 4.14 Reimburgement: Interest. If Mortgagee shall incur any Expenses or pay any Claims by reason of Mortgagor's failure to promptly pay or perform any of the Obligation within any applicable grace or cure periods, Mortgagee's payment of such Expenses and Claims shall constitute advances to Mortgagor which shall be paid by Mortgagor to Mortgagee on demand, together with deterest thereon from the date incurred until paid in full at the rate of interest their applicable to the Loan under the terms of the Note. Each advance shall be secured by the Mortgage and the other Loan Document at fully as if made to Mortgagor, regardless of the disposition thereof by the party or parties to whom such advance is made. Notwithstanding the foregoing, however, in any action or proceeding to foreclose the Mortgage or to recover or collect the Obligations, the provisions of Law governing the recovery of costs, disbursements and allowances shall prevail unaffected by this Section.
- Section 4.15 Notification by Mortgagor. Mortgagor will promptly give Notice to Mortgagee whenever Mortgagor has knowledge of the occurrence of any Default or Event of Default hereunder or under any of the other Loan Documents. Mortgagor will also promptly give Notice to Mortgagee of any claim of a default by Mortgagor, or any claim by Mortgagor of a default by any other party, under any property management contract or any Lease.
- Section 4.16 <u>Appreciate/Preperty Condition Assessment Report.</u> Mottgagee may obtain, in connection with the closing of the Loan, and at any time thereafter: (a) following the occurrence of an

Event of Default; or (b) Mortgagee has a good faith belief that the market conditions of the Property have been materially and adversely affected; or (c) when required by any regulatory body having jurisdiction over Mortgagee (and which requirement is not due to the Mortgagee's insolvency): (i) an appraisal of all or any part of the Property, prepared in accordance with written instructions from Mortgagee, from a third-party appraiser satisfactory to, and engaged directly by, Mortgagee; and (ii) a property condition assessment report for all or any part of the Property, prepared in accordance with written instructions from Mortgagee, from a third-party consultant satisfactory to, and engaged directly by Mortgagee. The reasonable cost of each such appraisal and each such property condition assessment report obtained by Mortgagee in accordance with the foregoing shall be borne by Mortgagor and shall be paid by Mortgagor on demand.

Article V Nogative Covenants and Agreements

- Section 5.1 Example and conditions of any existing Leases, Mortgagor will not permit any of the Property to become subject to any Encumbrance other than the Permitted Encumbrances. Within thirty (30) days after the filing of any mechanic's lien or other Lien or Encumbrance against the Property, Mortgagor will promptly discharge the same by payment or filing a bond or otherwise as permitted by I are So long as Mortgagee's security has been protected by the filling of a bond or otherwise in a manner satisfactory to Mortgagee in its sole and absolute discretion, Mortgagor shall have the right to concerning good faith any Claim, Lien or Encumbrance, provided that Mortgagor does so diligently and without rejudice to Mortgagee or delay in completing construction of the Improvements. Mortgagor shall give Mortgagee Notice of any default under any Lien and Notice of any foreclosure or threat of foreclosure with respect to any of the Property.
- Section 5.2 Transfer of the Preparty. Mortgage, will not Transfer, or contract to Transfer, all or any part of the Property or any legal or beneficial interast therein (except for certain Transfers of the Accessories expressly permitted in this Mortgage. The Transfer of any equity interest in Mortgager shall be deemed to be a prohibited Transfer of the Property.
- Section 5.3 Removal, Demalities or Alteration of Accessories and Improvements. Except to the extent permitted by the following sentence, no Improvements or Accessories shall be removed, demolished or materially altered by Mortgagor without the prior was en consent of Mortgagoe. Mortgagor may remove and dispose of, free from the Lien of this Mortgage, such Accessories as from time to time become worn out or obsolete, provided that, either: (a) at the time of, or prior to, such removal, any such Accessories are replaced with other Accessories which are free new other than Permitted Encumbrances and have a value at least equal to that of the replaced Accessories (and by such femoval and replacement Mortgagor shall be deemed to have subjected such Accessories of the Lien of this Mortgage); or (b) so long as a prepayment may be made without the imposition of any premium pursuant to the Note, such Accessories are sold at fair market value for cash and the net cash proceeds received from such disposition are paid over promptly to Mortgagee to be applied to the prepayment of the principal of the Loan.
- Section 5.4 Additional Improvements. Mortgagor will not construct any Improvements other than those presently on the Land without the prior written consent of Mortgagor. Mortgagor will complete and pay for, within a reasonable time, any Improvements which Mortgagor is permitted to construct on the Land. Mortgagor will construct and erect any permitted improvements: (a) strictly in accordance with all applicable Laws and any private restrictive covenants; (b) entirely on lots or parcels of the Land; (c) so as not to encroach upon any easement or right of way or upon the land of others; and (d) wholly within any building restriction and setback lines applicable to the Land.

Section 5.5 Restrictive Covenants. Zoning. etc. Without the prior written consent of Mortgagee, Mortgagor will not initiate, join in, or consent to any change in, any restrictive covenant, easement, zoning ordinance, or other public or private restrictions limiting or defining the uses which may be made of the Property. Mortgagor: (a) will promptly perform and observe, and cause to be performed and observed, all of the terms and conditions of all agreements affecting the Property; and (b) will do or cause to be done all things necessary to preserve intact and unimpaired any and all easements, appurtenances and other interests and rights in favor of, or constituting any portion of, the Property.

Article VI Events of Default

The occurrence or happening, from time to time, of any one or more of the following shall constitute an Gvert of Default under this Mortgage:

- Section 6.1 Payent Obligations. Mortgagor fails to pay any of the Obligations when due, whether on the scheduled due date or upon acceleration, maturity or otherwise.
- Section 6.2 <u>Default Unior Other Lean Documents</u>. An Event of Default (as defined therein) occurs under the Note or the Martes or any other Loan Document, or Mortgagor or Guarantor fails to promptly pay, perform, observe or comply with any term, obligation or agreement contained in any of the Loan Documents (within any applicable g ace or cure period).
- Section 6.3 Other Obligations. Mortgage (other than those expressly described in other Sections of this Article VI), and such failure continues uncured for a period of thirty (30) days after Notice from Mortgagee to Mortgagor, unless: (a) such failure, by its asture, is not capable of being cured within such period; and (b) within such period, Mortgagor commences to cure such failure and thereafter diligently prosecutes the cure thereof; and (c) Mortgagor causes such failure to be cured no later than ninety (90) days after the date of such Notice from Mortgagee.
- Section 6.4 Accuracy of Information: Representations and Cyrranties. Any information contained in any financial statement, schedule, report or any other document delivered by Mortgagor, any Guarantor or any other Person to Mortgagor in connection with the Loan pages at any time not to be in all material respects true and accurate, or Mortgagor, any Guarantor or any other Person shall have failed to state any material fact or any fact necessary to make such information not mixleading, or any representation or warranty contained in this Mortgago or in any other Loan Document when time to be incorrect or misleading in any material respect either on the date when made or on the Jate when reaffirmed pursuant to the terms of this Mortgage.
- Section 6.5 <u>Denosita.</u> Mortgagor fails to deposit funds with Mortgages, in the amount requested by Mortgages, pursuant to the provisions of Section 4.2(h), within ten (10) days from the effective date of a Notice from Mortgages requesting such deposit, or Mortgagor fails to deliver to Mortgages any Condemnation Awards or Insurance Proceeds within ten (10) days after Mortgagor's receipt thereof.
- Section 6.6 <u>Insurance Obligations.</u> Mortgagor fails to promptly perform or comply with any of the covenants contained in the Loan Documents with respect to maintaining insurance.
- Section 6.7 <u>Damage to Improvements.</u> The Improvements are substantially damaged or destroyed by fire or other casualty and Mortgagee determines that the Improvements cannot be restored in accordance with the terms and provisions of this Mortgage.

- Section 6.8 Lance of Permits or Approvals. Any permit, license, certificate or approval that Mortgagor is required to obtain with respect to any construction activities at the Property or the operation, leasing or maintenance of the Improvements or the Property lapses or ceases to be in full force and effect.
- Section 6.9 <u>Mechanic's Lieu.</u> A lien for the performance of work or the supply of materials filed against the Property, or any stop notice served on Mortgagor, any contractor of Mortgagor, or Mortgagee, remains unsatisfied or unbonded for a period of thirty (30) days after the date of filing or service.
- Section 6.10 <u>Bankruptey.</u> Mortgagor or any Guarantor files a bankruptcy petition or makes a general assignment for the benefit of creditors, or a bankruptcy petition is filed against Mortgagor or any Guaranta as a such involuntary bankruptcy petition continues undismissed for a period of thirty (30) days after the files thereof.
- Section 6.11 Appointment of Receiver, Trustee, Liquidator. Mortgagor or any Guarantor applies for or consents in writing to the appointment of a receiver, trustee or liquidator of Mortgagor, any Guarantor, the Property, or all or substantially all of the other assets of Mortgagor or any Guarantor, or an order, judgment or decreates entered by any court of competent jurisdiction on the application of a creditor appointing a receiver, trustee or liquidator of Mortgagor, any Guarantor, the Property, or all or substantially all of the other assets of Mortgagor or any Guarantor.
- Section 6.12 Inability to Pay Del & Jusolvency. Mortgagur or any Guarantor becomes unable or admits in writing its inability or fails generally to pay its debts as they become due.
- Section 6.13 <u>Judgment.</u> A final nonappealable judgment for the payment of money is entered against Mortgagor or any Guarantor, and Mortgagor or such Guarantor fails to discharge the same, or fails to cause it to be discharged or bonded off to Mortgagos's satisfaction, within thirty (30) days from the date of the entry of such judgment.
- Section 6.14 <u>Dissolution: Change in Business Status.</u> Unless the written consent of Mortgagee is previously obtained, all or substantially all of the business assets of Mortgagor or any Guarantor are sold, Mortgagor or any Guarantor is dissolved, or there occurs any charge in the form of business entity through which Mortgagor or any Guarantor presently conducts its inviness or any merger or consolidation involving Mortgagor or any Guarantor.
- Section 6.15 <u>Default Under Other Indebtedness.</u> Mortgagor or any Guararior fails to pay any indebtedness (other than the Loan) owed by Mortgagor or such Guarantor to Mortgagor or and as due and payable (whether by acceleration or otherwise).
- Section 6.16 <u>Death: Disability.</u> Any Guaranter dies or becomes incapacitated, unless, in 62 event of death, on or before the earlier of: (i) the expiration of the period for filing claims in the estate of such party; or (ii) sixty (60) days after such death, or, in the event of incapacity, within ninety (90) days after such incapacity a substitute Guaranter acceptable to Mortgages, in its sole and absolute discretion, agrees to assume and perform the obligations of such Guaranter in connection with the Loan and the Property.
- Section 6.17 <u>Material Adverse Change.</u> In the reasonable opinion of Mortgagee, the prospect of payment or performance of all or any part of the Obligations has been impaired because of a material adverse change in the financial condition, results of operations, business or properties of Mortgagor, any Guarantor or any other Person liable for the payment or performance of any of the Obligations.
- Section 6.18 Transfers. Mortgagor Transfers, or contracts to Transfer, all or any part of the Property or any legal or beneficial interest therein (except for Transfers of the Accessories expressly permitted

under this Mortgage). The Transfer of any equity interest in Mortgagor shall be deemed to be a prohibited Transfer of the Property constituting an Event of Default.

- Section 6.19 Event of Default Under Other Loan Documents. An Event of Default (as defined therein) occurs under the Note, or Mortgagor or Guarantor fails to promptly pay, perform, observe or comply with any obligation or agreement contained in any of the other Loan Documents (within any applicable grace or cure period).
- Section 6.20 <u>Change in Zoning or Public Restriction</u>. Any change in any zoning ordinance or regulation or any other public restriction is enacted, adopted or implemented that limits or defines the uses which hay be made of the Property such that the present or intended use of the Property, as specified in the Loan Locuments, would be in violation of such zoning ordinance or regulation or public restriction, as changed.
- Section 6.21 <u>Desired Under Leases</u>. Mortgagor fails duly to perform its obligations under any Lease and such failure is not card within the grace period, if any, provided in the Lease.
- Section 6.22 <u>Default Uniter Other Loan Documents</u>. A default occurs under any other mortgage or security agreement covering the Property, including any Permitted Encumbrances.
- Section 6.23 Execution: Attachm at Any execution or attachment is levied against any of the Property, and such execution or attachment is not set aside, discharged or stayed within thirty (30) days after the same is levied.

A.C. VII Rights and Apodies

Upon the happening of any Event of Default, Mongayer shall have the right, in addition to any other rights or remedies available to Mortgagee under any of the Loan Documents, applicable Law, or equity to exercise any one or more of the following rights, powers or remedies:

Section 7.1 Acceleration. Mortgages may accelerate all Obligations under the Loan Documents whereupon such Obligations shall become immediately due and payable, without notice of default, notice of acceleration or intention to accelerate, presentment or demand for payment, patest, notice of protest, notice of nonpayment or dishonor, or notices or demands of any kind or character (at of which are hereby expressly waived by Mortgagor).

Section 7.2 Mortrague's Right to Enter and Take Possession. Operate and Apply 1/20 mg.

- (a) Mortgagee may demand that Mortgagor surrender the actual possession of the Property and upon such demand, Mortgagor shall forthwith surrender same to Mortgagee and, to the extent permitted by law, Mortgagee itself, or by such officers or agents as it may appoint, may enter and take possession of all of the Property and may exclude Mortgagor and its agents and employees wholly therefrom.
- (b) If Mortgagor shall for any reason fail to surrender or deliver the Property or any part thereof after Mortgagoe's demand, Mortgagoe may obtain a judgment or order conferring on Mortgagoe the right to immediate possession or requiring the Mortgagor to deliver immediate possession to Mortgagoe, to the entry of which judgment or decree the Mortgagor hereby specifically consents.
 - (c) Mortgagee may from time to time: (i) continue and complete construction of,

hold, store, use, operate, manage and control the Property and conduct the business thereof; (ii) make all reasonably necessary maintenance, repairs, renewals, replacements, additions, betterments and improvements thereto and thereon and purchase or otherwise acquire additional Personalty; (iii) insure or keep the Property insured; (iv) exercise all the rights and powers of the Mortgagor in its name or otherwise with respect to the same; and (v) enter into agreements with others (including, without limitation, new Leases or amendments, extensions, or cancellations to existing Leases) all as Mortgagoe from time to time may determine in its sole discretion. Mortgagor hereby constitutes and irrevocably appoints Mortgagoe its true and lawful attorney-in-fact, which appointment is coupled with an interest, with full power of substitution, and empowers said attorney or attorneys in the name of Mortgagor, but at the option of said attorney-in-fact, to do any and all acts and execute any and all agreements that Mortgagor has a life foregoing.

hereinabove provided, collect and receive all the Rents therefrom, including those past due as well as those accruing therefor, and shall apply the monles so received first, to the payment of all costs and expenses (including, widrout limitation, costs of arbitration, reasonable attorneys' fees and expenses) incurred by Mortgagee and its agents in connection with the collection of same, whether or not in possession of the Property, and recond, in such order as Mortgagee may elect, to the payment of the Obligations.

Section 7.3 Proceedings To Recover Sums Due.

- (a) If any installment of part of any Obligation shall fail to be paid when due, Mortgagee shall be entitled to sue for and to recover judgment against the Mortgagor for the amount so due and unpaid together with all costs and expenses (including, without limitation, costs of arbitration, reasonable attorneys' fees and expenses) incurred by Mortgagee in connection with such proceeding, together with interest thereon at the default rate under the Nove from the date incurred by Mortgagee. Any such judgment against the Mortgagor shall bear interest at the maximum rate permitted by Law. All such costs and expenses shall be secured by this Mortgage and shall be due and payable by Mortgagor immediately.
- (b) If Mortgagor shall fail to pay upon the Mortgagor's Janand, after acceleration as provided herein, all of the unpaid Obligations, together with all accrued interest thereon, Mortgagoe shall be entitled to sue for and to recover judgment against the Mortgagor for the a tre amount so due and unpaid together with all costs and expenses (including, without limitation, costs of toin ation, reasonable attorneys' fees and expenses) incurred by Mortgagoe in connection with such processing together with interest thereon at the default rate under the Note from the date incurred by Mortgagor. Any such judgment against the Mortgagor shall bear interest at the maximum rate permitted by Law. All such costs and expenses shall be secured by this Mortgago and shall be payable by Mortgagor installately. Mortgagoe's right under this subsection may be exercised by Mortgagoe either before, after or during the pendency of any proceedings for the enforcement of this Mortgago, including appellate proceedings.
- (c) No recevery of any judgment as provided above and no attachment or levy of any execution upon any of the Property or any other property shall in any way affect the lien of this Mortgage upon the Property or any part thereof, or any lien, rights, powers, or remedies of Mortgagee hereunder, but such lien, rights, powers and remedies shall continue unimpaired as before.

Section 7.4 Foreciesure.

(a) Mortgagee may institute proceedings for the partial or complete foreclosure of this Mortgagee may, pursuant to any final judgment of foreclosure, sell the Property as an

entirety or in separate lots, units, or percels.

- Upon sale of the Property at any foreclosure, Mortgagee may credit bid (as determined by Mortgagee in its sole and absolute discretion) all or a portion of the Indebtedness. In regard to the above, Mortgagor acknowledges and agrees that (A) Mor go ree is not required to use any or all of the foregoing factors to determine the amount of its credit bid; (B) dr. Section does not impose upon Mortgagee any additional obligations that are not imposed by law at the time the credit bid is made; (C) the amount of Mortgagee's credit bid need not have any relation to any loan to value ratios specified in the Loan Documents or previously discussed between Mortgagee and Mortgages, and (D) Mortgagee's credit bid may be higher or lower than any appraised value of the Property.
- (c) It is the intention of Mortgagee and Mortgagor that the enforcement of the terms and provisions of this Mortgage small be accomplished in accordance with the Illinois Mortgage Foreclosure Law (the "Act"), 735 ILCS 5(15) 1:01 et seq., and with respect to such Act, Mortgagor agrees and covenants that:
- Mortgagee shall have the terafit of all of the provisions of the Act, including all amendments thereto which may become effective fire time after the date hereof. In the event any provision of the Act which is specifically referred to herein may be repealed, Mortgagee shall have the benefit of such provision as most recently existing provide such repeal, as though the same were incorporated herein by express reference. If any provision in his Mortgage shall be inconsistent with any provision of the Act, provisions of the Act shall take precedence or or the provisions of this Mortgage, but shall not invalidate or render unenforceable any other provision of the Martgage that can be construed in a manner consistent with the Act. If any provision of this Mortgage shall gove to Mortgagee (including Mortgagee acting as a mortgagee-in-possession), or a receiver appointed put a ant to the provisions of this Mortgage, any powers, rights or remedies prior to, upon or following the occurrence of an Event of Default which are more limited than the powers, rights or remedies that would of erwise be vested in Mortgages or in such receiver under the Act in the absence of said provision, Mortgages and such receiver shall be vested with the powers, rights and remedies granted in the Act to the full extent permitted by law. Without limiting the generality of the foregoing, all expenses incurred by Mortgagee which are of the type referred to in Section 5/15-1510 or 5/15-1512 of the Act, whether incurred before or after any decree or judgment of foreclosure, and whether or not enumerated specifically in this Mortonce. shall be added to the indebtedness secured hereby and/or by the judgment of foreclosure.
- (e) Wherever provision is made in this Mortgage or the Loan Documents for insurance policies to bear mortgage clauses or other loss payable clauses or endorsements in favor of Mortgagee, or to confer authority upon Mortgagee to settle or participate in the settlement of losses under policies of insurance or to hold and disburse or otherwise control the use of insurance proceeds, from and after the entry of judgment of foreclosure, all such rights and powers of Mortgagee shall continue in Mortgagee as judgment creditor or mortgagee until confirmation of sale.
- (f) In addition to any provision of this Mortgage authorizing Mortgagee to take or be placed in possession of the Property, or for the appointment of a receiver, Mortgagee shall have the right,

in accordance with Sections 15-1701 and 15-1702 of the Act, to be placed in the possession of the Property or at its request to have a receiver appointed, and such receiver, or Mortgagee, if and when placed in possession, shall have, in addition to any other powers provided in this Mortgage, all rights, powers, immunities, and duties and provisions for in Sections 15-1701 and 15-1703 of the Act.

- (g) Mortgagor acknowledges that the Property does not constitute agricultural real estate, as said term is defined in Section 15-1201 of the Act or residential real estate as defined in Section 15-1219 of the Act. The Loan is a business loan which comes within the purview of Section 205/4, paragraph (1)(1) of Chapter \$15 of the Illinois Compiled Statutes, as amended.
- (h) Mortgagor hereby expressly waives any and all rights of reinstatement and redemption of any, under any order or decree of foreclosure of this Mortgage, on its own behalf and on behalf of each and every person, it being the intent hereof that any and all such rights of reinstatement and redemption of king agor and of all other persons are and shall be deemed to be hereby waived to the full extent permitted by the provisions of Section 5/15-1601 of the Act or other applicable law or replacement statutes.
- (i) In case of a foreclosure sale of all or any part of the Property, the proceeds of sale shall be applied in accordance with Section 7.14 hereof, and the Mortgagee shall be entitled to seek a deficiency judgment against the Mortgagor to enforce payment of any and all Obligations then remaining due and unpaid, together with interest the eon, and to recover a judgment against the Mortgagor therefor, which judgment shall bear interest at the last items rate permitted by Law.
- (i) The Mortgagee is authorized to foreclose this Mortgage subject to the rights of any tenants of the Property, or Mortgagee may ever which tenants Mortgagee desires to name as parties defendant in such foreclosure and failure to make any such tenants parties defendant to any such foreclosure proceedings and to foreclose their rights will rathe, nor be asserted by the Mortgager to be, a defense to any proceedings instituted by the Mortgagee to collect the unpaid Obligations or to collect any deficiency remaining unpaid after the foreclosure sale of the Property.
- Section 7.5 Receiver. Mortgages may apply to any court of composite jurisdiction to have a receiver appointed to enter upon and take possession of the Property, collect the Parts therefrom and apply the same as the court may direct, such receiver to have all of the rights and powers permitted under the laws of the State. The right of the appointment of such receiver shall be a matter of state right without regard to the value or the occupancy of the Property or the solvency or insolvency of Mortgager. The expenses, including receiver's fees, attorneys' fees, costs and agent's commission incurred part to the powers herein contained, together with interest thereon at the default rate under the Note, shall or sourced hereby and shall be due and payable by Mortgagor immediately without notice or demand. Notwinstanding the appointment of any receiver or other custodian, Mortgages shall be entitled as pledges to the passession and control of any cash or deposits at the time held by, payable, or deliverable under the terms of this Mortgages to the Mortgages, and the Mortgages shall have the right to offset the unpaid Obligations against any such cash or deposits in such order as Mortgages may elect.
- Section 7.6 Remedies as to Personalty. Mortgagee may exercise any or all of its rights and remedies under the Uniform Commercial Code-Secured Transactions as adopted by the State as in effect from time to time; (or under the Uniform Commercial Code in force from time to time in any other state to the extent the same is applicable law) or other applicable law as well as all other rights and remedies possessed by Mortgagee, all of which shall be cumulative. Mortgagee is hereby authorized and empowered to enter the Property or other place where the Personalty may be located without legal process, and to take possession of the Personalty without notice or demand, which hereby are waived to the maximum extent permitted by the laws of the State. make the Personalty available to Mortgagee at a place reasonably convenient to Mortgagee. - Section 7.7 Other. Mortgagee may institute and maintain any suits and proceedings as the Mortgagee may deem advisable: (i) to prevent any impairment of the Property by any acts which may be unlawful or in violation of this Mortgage; (ii) to preserve or protect its interest in the Property; and (iii) to restrain the enforcement of or compliance with any Laws that may be unconstitutional or otherwise invalid, if the enforcement of or compliance with such Laws might impair the security hereunder or be prejudically) the Mortgagee's interest.
- Section 7.8 Remedies Cumulative and Concurrent. No right, power or remedy of Mortgages as provided in the lote, this Mortgage, the Guaranty, or the other Loan Documents is intended to be exclusive of any concurrent and in addition to any other right, power or remedy available to Mortgages now or hereafter existing at law or in equity and may be pursued separately, successively or together against Mortgagor any Guarantor, or any endorser, co-maker, surety or guarantor of the Obligations, or the Property of any part thereof, or any one or more of them, at the sole discretion of Mortgages. The failure of Mortgages to exercise any such right, power or remedy shall in no event be construed as a waiver or release thereof.
- Section 7.9 Waiver, Delay or Omiesica No waiver of any Event of Default hereunder shall extend to or affect any subsequent or any other Event of Default then existing, or impair any rights, powers or remedies consequent thereon, and no delay or or impair any right, power or remedy shall be construed to waive any such Event of Cefault or to constitute acquiescence therein.
- Section 7.10 <u>Credit of Mortrages.</u> To the maximum of ort permitted by the laws of the State, upon any sale made under or by virtue of this Article, Mortgagee may bid for and acquire the Property, or any part thereof, and in lieu of paying cash therefor may apply to the ourclasse price, any portion of or all of the unpaid Obligations in such order as Mortgagee may elect.
- Section 7.11 Sale. Any sale or sales made under or by virtue of this Arabie shall operate to divest all the estate, right, title, interest, claim and demand whatsoever at law or in equity, of the Mortgagor and all Persons, except tenants pursuant to Leases and extension of any Leases existing as or the date hereof or any future Leases approved by Mortgagee, claiming by, through or under Mortgage in and to the properties and rights so sold, whether sold to Mortgagee or to others.
- Section 7.12 Proofs of Claim. In the case of any receivership, insolvency, ackruptcy, reorganization, arrangement, adjustment, composition, seizure of the Property by any Governmental Authority, or other judicial proceedings affecting the Mortgagor, any Guarantor, any endorser, co-maker, surety, or guarantor of the Obligations, or any of their respective properties, the Mortgagoe, to the extent permitted by law, shall be entitled to file such proofs of claim and other documents as may be necessary or advisable in order to have its claim allowed in such proceedings for the entire unpaid Obligations at the date of the institution of such proceedings, and for any additional amounts which may become due and payable after such date.
- Section 7.13 <u>Waiver of Redemption. Notice. Marshalling. Etc.</u> Mortgagor hereby waives and releases, for itself and anyone claiming through, by, or under it, to the maximum extent permitted by the laws of the State:

- (a) all benefit that might accrue to Mortgagor by virtue of any present or future law exempting the Property, or any part of the proceeds arising from any sale thereof, from attachment, levy or sale on execution, or providing for any appraisement, valuation, stay of execution, exemption from civil process, redemption or extension of time for payment,
- (b) unless specifically required herein, all notices of default, or Mortgagee's actual exercise of any option or remedy under the Loan Documents, or otherwise, and
 - (c) any right to have the Property marshalled.
- Section (1) Application of Proceeds. The proceeds of any sale of all or any portion of the Property shall be applied by Mortgagee first, to the payment of receiver's fees and expenses, if any, and to the payment of all costs and expenses (including, without limitation, reasonable attorneys' fees and expenses) incurred by Matroce, together with interest thereon at the default rate under the Note from the date so incurred, in connection with any entry, action or proceeding under this Article and, second, in such order as Mortgagee may elect, to the payment of the Obligations. Mortgager shall be and remain liable to Mortgagee for any difference between the net proceeds of sale and the amount of the Obligations until all of the Obligations have been or'd in full.
- Section 7.15 <u>Discontinuance of Proceedings</u>. If Mortgagee shall have proceeded to enforce any right under any Loan Document and such proceedings shall have been discontinued or abandoned for any reason, then except as may be provided in say written agreement between Mortgager and Mortgagee providing for the discontinuance or abandona ent of such proceedings, Mortgager and Mortgagee shall be restored to their former positions and the rights, rune lies and powers of Mortgagee shall continue as if no such proceedings had been instituted.
- Section 7.16 Mortgages's Actions. Mortgages may, at any time without notice to any Person and without consideration, do or refrain from doing any or all of the following actions, and neither the Mortgagor, any Guarantor, any endorser, co-maker, surety or guarantor of the Obligations, nor any other Person (hereinafter in this Section collectively referred to as the (bilg) now or hereafter liable for the payment and performance of the Obligations shall be relieved from the regiment and performance thereof, unless specifically released in writing by Mortgagee: (a) renew, extend or and diffy the terms of the Note. this Mortgage, the Guaranty and the other Loan Documents, or any of them; (i) forbear or extend the time for the payment or performance of any or all of the Obligations; (c) apply payments by any Obligor to the reduction of the unpaid Obligations in such manner, in such amounts, and at such tirges and in such order and priority as Mortgagee may see fit; (d) release any Obligor; (e) substitute or release in whole or in part the Property or any other collateral or any portion thereof now or hereafter held as so unity for the Obligations without affecting, disturbing or impairing in any manner whatsoever the validity and priority of the lien of this Mortgage upon the Property which is not released or substituted, or the Willity and priority of any security interest of the Mortgagee in such other collateral which is not released or substituted; (f) subordinate the lien of this Mortgage or the lien of any other security interest in any other collateral now or hereafter held as accurity for the Obligations; (g) join in the execution of a plat or replat of the Land (provided, however, notwithstanding the foregoing, Mortgagee will join in such plat or replat of the Land so long as such plat or replat is acceptable to Mortgagee); (h) join in and consent to the filling of a declaration of condominium or declaration of restrictive covenants regarding all or any part of the Land; (i) consent to the granting of any easement on the Land; and (j) generally deal with any obligor or any other party as Mortgagee may see fit.
- Section 7.17 Mortgages Actions. Following an Event of Default in the performance of any of Mortgagor's covenants or agreements contained in this Mortgage or any other Loan Document or the violation of any term thereof, Mortgages shall have the right (but in no event the obligation) at its option

to cure the Event of Default or take any other action Mortgagee deems necessary or desirable to protect its security (including without limitation the payment of any taxes, assessments, insurance premitums, charges, liens or encumbrances required of Mortgagor under this Mortgage), without hereby waiving any rights remedies otherwise available to Mortgagee. If Mortgagee shall elect to advance at any time any sum(s) for the protection of its security or for any other reason permitted or provided by any of the terms of this Mortgage or of any other Loan Document, then such sum(s) shall be deemed Loan funds, shall be secured by this Mortgage and shall bear interest until paid at the Default Rate provided in the Note commencing on the date they are advanced by Mortgagee. If advanced by Mortgagee before the (natural or accelerated) maturity date of the Note, such sum(s) shall be due and payable by Mortgagor on such maturity date or ten (10) days after Mortgagor first learns of the advance, whichever is earlier, but if advanced after the (natural or accelerated) maturity date, such sum(s) shall be due and payable immediately. Mortgagee's lien on the Premises for such advances shall be superior to any right to title to, interest in, or claim upon all or any portion of the Premises junior to the lien of this Mortgage. Without the prior written consent of Mortgagee, which Mortgagee may grant or withhold in its sole discretion, Mortgagor shall we file for record any notice limiting the maximum principal amount that may be secured by this Mortge can any amount less than the limit set forth in the future advance clause.

Section 7.18 Other Remedia. Mortgagee shall have the right from time to time to protect, exercise and enforce any legal or equitable recedy against Mortgagor provided under the Loan Documents or by applicable Laws.

Article VIII

Section 8.1 Rights. Powers and Remedia Annulative. Each right, power and remedy of Mortgagee as provided for in this Mortgage, or in any of the other Loan Documents or now or hereafter existing by Law, shall be cumulative and concurrent and shall be in addition to every other right, power or remedy provided for in this Mortgage, or in any of the other Loan Documents or now or hereafter existing by Law, and the exercise or beginning of the exercise by Martgages of any one or more of such rights, powers or remedies shall not preclude the simultaneous or later or excise by Mortgagee of any or all such other rights, powers or remedies.

No Waiver by Mortsacce. No course of dealing or conductory or among Mortgagee and Section 8.2 Mortgagor shall be effective to amend, modify or change any provisions of the Mortgage or the other Loan Documents. No failure or delay by Mortgagee to insist upon the strict performance of any term. covenant or agreement of this Mortgage or of any of the other Loan Documents, or to gracise any right, power or remedy consequent upon a breach thereof, shall constitute a waiver of any such raim, covenant or agreement or of any such breach, or preclude Mortgages from exercising any such right, power or remedy at any later time or times. By accepting payment after the due date of any of the Oil gations, Mortgagee shall not be deemed to waive the right either to require prompt payment when due of all other Obligations, or to declare an Event of Default for failure to make prompt payment of any such other Obligations. Neither Mortgagor nor any other Person now or hereafter obligated for the payment of the whole or any part of the Obligations shall be relieved of such liability by reason of: (a) the failure of Mortgagee to comply with any request of Mortgagor or of any other Person to take action to foreclose this Mortgage or otherwise enforce any of the provisions of this Mortgage, or (b) any agreement or stipulation hetween any subsequent owner or owners of the Property and Mortgagee, or (c) Mortgagee's extending the time of payment or modifying the terms of this Mortgage or any of the other Loan Documents without first having obtained the consent of Mortgagor or such other Person. Regardless of consideration, and without the necessity for any notice to or consent by the holder of any subordinate Lien on the Property. Mortgagee may release any Person at any time liable for any of the Obligations or any part of the security for the Obligations and may extend the time of payment or otherwise modify the terms of this Mortgage
