### MORTGAGE MODIFICATION AGREEMENT

This Mortgage Modification Agreement ("Agreement") is made as of October 31, 2019, between CHICAGO TITLE LAND 1RUST COMPANY, not personally but as Trustee under Trust Agreement dated October 27, 2014 and known as Trust No. 8002376264 ("Borrower") and H. ## **RECITALS**

- A. Borrower executed and delivered to Stephen P. Sandler, the then current Trustee of Lender, a certain Note dated November 9, 2017, in the principal amount of \$1,100,000.00 maturing November 8, 2037 (the "Note").

The Note was secured by a First Mortgage, dated November 9, 2017 and recorded on November 21, 2017 with the Recorder of Deeds of Cook County, Union as Document 1732515138, encumbering the property commonly known as 1832 N. Horore, Chicago, Illinois 60605 as legally described in Exhibit A attached to this Agreement (the "Property").
