- On August 7, 2019, Lien Claimant substantially completed all required by said 5. contract and extras.
- 6. Contractor is entitled to credits on account thereof as follows: \$3,416,669.34, leaving due, unpaid and owing to Lien Claimant, after allowing all credits, the sum of \$893,837.13 for which, with interest, Lien Claimant claims a lien on the premises and improvements and to monies or other considerations due or to become due from Owner under said contract between Contractor and Owner.
