WHEREFORE, based on the foregoing, the decedent left a surviving heir at law, the following who is of legal age and mentally competent:

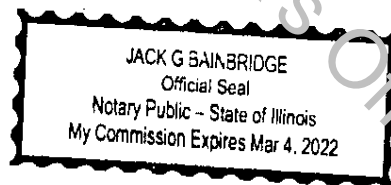
