That in or about October of 2019, Claimant contracted with the Owner and/or the Owner's duly authorized or designated agent, acting on behalf of Owner as one whom the Owner knowingly permitted to contract for the improvements, for the provision of all labor, equipment, and materials for certain exterior masonry work at the Property, including the construction of exterior masonry walls, per plans and specifications provided by the Owner ("Masonry Work").

3. The initial contract with Claimant for the Masonry Work at the Property totaled \$9,500.00.

4. That upon special request and with the Owner's approval, Claimant provided extra materials and labor related to the Masonry Work, including the removal, installation, and relocation of masonry scaffolding, in the amount of Six Hundred and Fifty Dollars (\$650.00). All of which was accepted by and approved by the Owner.

5. As of October 16, 2019 the last date on which Claimant provided such labor and material for the Masonry Work, Cicimant had completed \$10,150.00 of the Masonry Work required of it in a good and workmanlike manner as called for under contract and at the request of Owner and/or Owner's duly authorized agont.

6. That after allowing for all just credits there remains that sum of **Ten Thousand**One Hundred Fifty and 00/100 (\$10,150.00) rightfully due and owing Claimant under its
Contract with Owner, for which the Claimant claims a lien, with interest at a rate of ten (10%)
percent from the last date of work, all pursuant to Illing's Statute, on said Property and improvements, and on the monies or other considerations due or to become due from the Owner under said contract.
