WITNESSETH.

WHEREAS, the Board of Directors ("Board") of the Association admrasters the condominium property located in the City of Chicago, County of Cook, State of Illinois, legally describe I on Exhibit A attached hereto and made a part hereof;

WHEREAS, the property was submitted to the provisions of the Illinois Condominium Property Act (the "Act") pursuant to the Declaration of Condominium Ownership and of Easements, Restrictions, Covenants, and By Laws for the Residences at 401 N. Wabash Avenue, a Condominium, recorded in the Cook County Recorder of Deed's Office as Document No. 0821716050, as subsequently amended (the "Declaration"). All capitalized terms shall have the meaning ascribed to them in the Declaration unless otherwise expressly defined herein;

WHEREAS, Ross Berman and Sara Berman are the record owners of Unit 58D (collectively, the "58D Owner") in the Association.

WHEREAS, Storage Locker S4308 ("Storage Locker S4308") is assigned to said Unit 58D as a Limited Common Element appurtenant to Unit 58D.

WHEREAS, Mark D. Hellman and Deborah L. Hellman are the record owners of Unit 43G (collectively the "43G Owner") in the Association;

WHEREAS, Storage Locker S3002 ("Storage Locker S3002") is assigned to said Unit 43G as a Limited Common Element appurtenant to Unit 43G;

WHEREAS, the Unit 58D Owner and the Unit 43G Owner are desirous of transferring Storage Locker S4308 from Unit 58D to Unit 43G and Storage Locker S3002 from Unit 43G to Unit 58D.

WHEREAS, the Declaration and Section 26 of the Act provide that a Limited Common Element may be transferred between Unit Owners by an amendment to the Declaration executed by all Unit Owners who are parties to the transfer and containing a certificate showing that a copy of the Amendment has been delivered to the board of managers, subject only to the prior written consent of the holder of any first mortgage on the Unit transferring the Limited Common Element.

NOW THEREFORE, the Unit 58D Owner and the Unit 43G Owner (collectively, the "Owners") hereby agree as follows:

- (1) Storage Locker \$4398 shall hereby be assigned to Unit 43G and Storage Locker \$3002 shall hereby be assigned to Unit 58D;
- (2) The Declaration shall or manned to reflect the assignment and transfer of Storage Locker S4308 to Unit 43G and Storage Locker S3002 shall noteby be assigned to Unit 58D;
- (3) The Owners agree that the percentage ownership interests assigned to Units 58D and 43G, respectively, shall not be modified as a result of the foregoing the affects of Storage Locker S4308 and Storage Locker S3002; and
- (4) Except as expressly amended hereby, the Declaration shall remain in full force and effect in accordance with its terms.
