Any party dealing with the Trustee(s) with regard to the trust property, whether by contract, sale, mortgage lease or otherwise, shall not be required to see to the application of the purchase money, loan proceeds, rental or other consideration given, nor shall be required to see that the terms of the trust have been complied with, or to inquire into the powers and authority of the Trustee(s), and the execution of every contract, option, deal, mortgage or other instrument dealing with the trust property, shall be conclusive evidence in favor of every person relying upon or claiming under such conveyance or other instrument; that at the time of the execution and delivery of any of the aforesaid instruments, the Trust Agreement above described was in full force and effect; that said instrument so executed was pursuant to and in accordance with the authority granted the Trustee(s), and is binding upon the beneficiary or beneficiaries under said Trust Agreement, and if said instrument is executed by a successor or successors in trust, that he or they were duly appointed and are fully invested with the title, estate, rights, powers, and duties of the Preceding Trustee(s).
- 3. The interest of each and every beneficiary under said Trust Agreement and hereunder, and all persons claiming under any of the beneficiaries, shall be only in the earnings, avails and proceeds arising from the sale or other disposition of the trust property, and such interest is hereby declared to be personal property only, and the beneficiary or beneficiaries of the trust shall not have any title or interest herein, legal or equitable, except as stated.
- 4. In the event of the inability (or refusal) of the Trustee(s) herein named to act, or upon his/her/their removal from the Courty, CINDY VALDEZ, of 3810 N. Sayre, Chicago, Illinois 60634, shall be appointed as Successor Trustee, with like powers and authority as vested in the Trustee(s) named herein.
- 5. In the event of the inability (or refusal) of the Successor Trustee(s) herein named to act, or upon his/her/their removal from the County, CESAR V. VALDEZ, of 3810 N. Sayre, Chicago, Illinois 60634, shall be appointed as Alternate Successor Trustee, with like powers and authority as vested in the Trustee(s) named herein.

All of the covenants, conditions, powers, rights, duties vested hereby, in the respective parties, shall inure to and be binding upon their heirs, legal representatives, and assigns.

The Grantor hereby waives and releases any and all right and benefit under and by virtue of the Homestead Exemption Laws of the State of Illinois.
