- On or about May 17, 2019, Claimant entered into a written subcontract agreement with Alpha Construction Services, LLC ("General Contractor") who, on information and belief, is the General Contractor of Owner, to furnish labor, material, and equipment to perform demolition work at the Premises.
- 4. Claimant completed the furnishing of all such demolition and other related services on or about September 6, 2019, and all of the same were used and/or incorporated into the improvement located upon the Premises.
- 5. There is now justly due and owed Claimant for the agreed contract price and authorized extras for all such demolition and other related services, after allowing the Owner and General Contractor all credits for prior payments made upon the contract of Claimant, the sum of Sixty-Six Thousand Five Hundred and 00/100 Dollars (\$66,500.00), all of which is still due and unpaid.
- 6. On October 7, 2019, the Claimant did cause to be mailed a Notice of Claim of Subcontractor to Owners and Lenders Pursuant to 770 ILCS 60/24, in the form of Certified Mail, Return Receipt Requested.
