EXHIBIT A TO FINANCING STATEMENT

Description of Collateral

The Collateral is:

- (1) All machinery, apparatus, equipment, fittings, fixtures, and articles of personal property of every kind and nature whatsoever located now or in the future in or upon the property (the "Premises") and used or useable in connection with any present or future operation of the Premises (all of which is called "Equipment");
- (2) All mineral, oil, gas and water rights, royalties, water and water stock, timber and timber rights, if any;
- (3) All awards or payments including interest made as a result of: the exercise of the right of eminent domain; the alteration of the grade of any street, any loss of or damage to any building or other improvement on the Premises, any other injury to or decrease in the value of the Premises, any refund due on account of the payment of real estate taxes, assessments or other charges levied against or imposed upon the Premises; and
- (4) All of the rents, issues and profits of the Premises under present or future leases, or otherwise.
