MEMORANDUM OF LONG-TERM OPERATING SUBSIDY AGREEMENT

THIS MEMC RAINDUM OF LONG-TERM OPERATING SUBSIDY AGREEMENT, dated as of the 28th day of January, 2075 (this "Memorandum"), is entered into by and between Hope Manor Village Housing Limited Partnership, an Illinois limited partnership (the "Owner"), and the CHICAGO LOW-INCOME HOUSING TRUST FUND, an Illinois not-for-profit corporation (the "Trust Fund").

WITNESSETH:

WHEREAS, the Trust Fund and the Gamer have entered into that certain Long-Term Operating Subsidy Agreement dated as of January 28, 2020 (the "LTOS Agreement"), and that certain Escrow Agreement dated as of January 28, 2020 (the "Escrow Agreement", which is appended to the LTOS Agreement as Exhibit M; the Escrow Agreement, together with the LTOS Agreement, collectively are the "Agreement"), pursuant to which the Trust Fund has agreed to provide certain rental subsidy payments to the Owner to be used with respect to that certain property described on Exhibit A hereto (the "Property") and in accordance with the terms, conditions and covenants set forth therein; and

WHEREAS, the Trust Fund and the Owner desire to place of record the existence of the Agreement together with certain of its terms.

NOW THEREFORE, in consideration of the premises and the mutual covenants set forth herein and therein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto covenant and agree as follows:

- 1. All of the terms, provisions, covenants and agreements between the Trust Fund and the Owner are set forth in the Agreement. Five (5) 2-bedroom units at the Property must be leased to tenants earning incomes at or below 30% of the area median income and five (5) 2-bedroom units at the Property which must be leased to tenants earning incomes at or below 15% of the area median income (the "Use Restrictions").
- 2. Except as otherwise permitted in the Agreement, the Owner is prohibited from the sale, transfer or conveyance of the Property or any other transfer of ownership interests affecting the Property or the Agreement without the prior written consent of the Trust Fund (the "Sale Restrictions").
- 3. Unless the Agreement is terminated or otherwise expires earlier, in accordance with the terms of the Agreement, the Use Restrictions, Sale Restrictions and all other obligations set forth in the Agreement, shall remain in effect until January 1, 2036.
