THIS REASSIGNMENT OF PLEDGED NOTES RECEIVABLE AND TIMESHARE INTEREST MORTGAGES ("Reassignment") is made and executed as of January 6, 2020, by CAPITAL ONE, NATIONAL ASSOCIATION, a national banking association ("Agent"), to SECOND CITY RESORTS, LLC, an Illinois limited liability company (the "Borrower").
