# MODIFICATION TO LCAN DOCUMENTS

THIS MODIFICATION TO LOAN POCUMENTS (this "Modification") is dated February 12, 2020, by and between CRFRE – BO'DRGMONT, LLC – SERIES PLEASANT COURT, an Illinois limited liability company ("Mortgagor"), and WINTRUST BANK N.A. f/k/a Wintrust Bank ("Lender").

### <u>WITNESSETH</u>

- A. Lender has made available a loan to Mortgagor in the principal amount of \$13,600,000.00 ("Loan"), as evidenced by that certain Amended and Res ated Promissory Note in the principal amount of \$13,600,000.00 of even date herewith, made by Mortgagor in favor of Lender (the "Note").
- B. The Note is secured by, among other things: (i) that certain Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Filing dated February 7, 2019 made by Mortgagor in favor of Lender and recorded on February 19, 2019 with the Cook County Recorder of Deeds as Document Number 1905049222 (the "Mortgage"); (ii) that certain Assignment of Leases and Rents dated February 7, 2019 made by Mortgagor in favor of Lender and recorded on February, 7 2019 with the Cook County Recorder of Deeds as Document Number 1905049223 (the "ALR"); (iii) that certain Security Agreement dated February 19, 2019 made by Mortgagor in favor of Lender (the "Security Agreement"); (iv) that certain Limited Guaranty executed by Bradford B. Couri (the "Guarantor") in favor of Lender ("Limited Guaranty"); and (v) that certain Environmental Indemnity Agreement made by Mortgagor and Guarantor in favor of Lender ("Indemnity," which together with the Note, Mortgage, ALR, Security Agreement, Limited Guaranty, and all other documents evidencing and securing the Loan shall be referred to herein collectively as the "Loan Documents").

- C. The property encumbered by the Mortgage and ALR is commonly known as 932 Pleasant Street, Chicago, Illinois, and is legally described on <u>Exhibit A</u> attached hereto and made a part hereof.
- D. Mortgagor desires, and Lender has agreed, to amend certain terms of the Loan as reflected in the Note and to make such other amendments and modifications as may be set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree that the Loan Documents be and are hereby modified and amended as follows:

### 1. Amendment to the Loan Documents.

- (a) The indebtedness secured by the Mortgage is increased to the Loan amount, as reflected in the Note. All references in the Loan Documents to: (i) the Note shall be deemed to refer to the Note (as defined herein); and (ii) the Loan Documents shall be deemed to include this Modification.
- (b) Simultaneously with the execution hereof, the Guarantor shall execute and deliver that certain Amendment to and Reaffirmation of Limited Guaranty (the "Guaranty Amendment"), and all references in the Loan Documents to the Limited Guaranty shall hereafter be deened to refer to the Limited Guaranty, as modified by the Guaranty Amendment.
- 2. <u>Full Force and Effect</u>. The provisions of the Loan Documents, as respectively amended hereby, are in full force and effect and the Loan Documents as so amended are hereby ratified and confirmed.
- 3. <u>Priority</u>. Nothing herein contained shall in any manner affect the lien or priority of the Loan Documents, or the covenants, conditions and agreements therein contained, as amended.
- 4. <u>Conflict</u>. In the event of conflict between any of the provisions of the Loan Documents and this Modification, the provisions of this Modification shall confice.
- 5. <u>Representations</u>. Mortgagor hereby renews, remakes and reaffirms the representations and warranties contained in the Loan Documents.
- 6. <u>Counterparts</u>. This Modification may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument, and any party hereto may execute this Modification by signing one or more counterparts.
- 7. <u>Binding</u>. This Modification is binding upon, and inures to the benefit of, the parties hereto and their respective successors and assigns.
