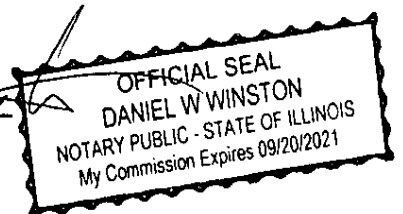

LEGAL DESCRIPTION

PARCEL 1:

Unit 312-P in the University Village Lofts Condominium as delineated and defined on the plat of survey of the following described parcel of real estate:
