In the event of any conflict between the terms of this Memorandum and the terms of the Agreement, as it may be amended from time to time, the terms of the Agreement shall govern and control.

- 5. <u>Counterparts</u>. This Memorandum may be executed in any number of counterparts, each of which when so executed and delivered will be deemed to be an original and all of which counterparts taken together will constitute one and the same instrument.
- 6. <u>Successors</u>. The covenants and conditions made and entered into by the parties hereto shall be binding upon and inure to the benefit of their respective successors and assigns.


