This Amendment is recorded for the purpose of amending the Declaration of Condominium Ownership (hereinafter the "Declaration") for Barcelona No. 7 Condominium Association (hereinafter the "Association"), which Declaration was recorded on September 22, 2011, as Document No. 1120518012, in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereinafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provision of Article XIII, Section 13.08 of the Declaration. Article XIII, Section 13.08 of the Declaration provides that the Declaration may be amended, changed or modified by an instrument in writing setting forth such amendment, change or modification, signed and acknowledged by the members of the Board, the Owners having at least three-fourths (3/4) of the total vote and containing an affidavit by an officer of the Board certifying that a copy of the amendment, change or modification has been mailed by certified mail to all mortgagees having bona fide liens of record against any Unit Ownership, not less than ten (10) days prior to the date of such affidavit. An amendment to the Declaration must also be recorded in the Office of the Recorder of Deeds of Cook County, Illinois.

RECITALS

WHEREAS, the Board and the Owners desire to amend the Declaration in order to provide for the orderly operation of the Property; and

WHEREAS, the foregoing Amendment has been signed and acknowledged by all members of the Board; and

WHEREAS, the approval of at least 3/4ths of the Owners have approved the amendment to the Declaration, said approvals attached hereto and made a part hereof.

WHEREAS, a copy of the foregoing Amendment was mailed by certified mail to all mortgagees having bona fide liens of record against any Unit Ownership, as evidenced by the affidavit attached hereto as Exhibit C.

NOW, THEREFORE, the Declaration for the Barcelona No. 7 Condominium Association is hereby amended in accordance with the text which follows (additions in text are indicated by an underline; deletions by ~~strike-outs~~):

1. Article IV, Section 4.03(k)(1) shall be amended as follows:

(b) By the Unit Owner. Except as otherwise provided in paragraph (a) above or paragraph (c) below, each Unit Owner shall furnish and be responsible for, at his own expense:

(1) All of the maintenance, repairs and replacements within his own Unit, all interior doors appurtenant thereto, all screens and windows, and all internal installations of such Unit such as refrigerators, ranges, and other kitchen appliances, lighting fixtures and other electrical fixtures and plumbing, and any portion of any other utility service facilities located within the Unit. ~~provided, however, that such maintenance, repairs and replacements as may be required for the bringing of water and electricity to the Units, shall be furnished by the Board as part of the Common Expenses.~~ Additionally, notwithstanding anything to the contrary contained herein, owners shall be responsible for the maintenance, repair and replacement of any plumbing or electrical lines that serves the unit exclusively.

2. Article VII, Section 7.01(g) of the Declaration is hereby amended as follows:

(g) Impairment of Structural Integrity of Building. Nothing shall be done in any Unit or in, on or to the Common Elements which will impair the structural integrity of the Building or which would structurally change the Building except as is otherwise provided herein. No Unit Owner shall overload the electric wiring in the Building, or operate any machines, appliances, accessories or equipment in

such manner as to cause, in the judgment of the Board, an unreasonable disturbance to others. Owners may be permitted to install washing machines in their Unit, subject to the following conditions:

- (1) Prior to the installation of the machine, the Owner must obtain the written approval of the Board and provide copies of any permits as required by the City of Skokie;
- (2) Owner must agree to upgrade the plumbing for the entire building tier for said Unit, in accordance with the specifications required by the Board; and
- (3) Owner must install appropriate flooring under the appliance, as required by the Board.
- (4) Owner may only install specific ultra quiet models approved in writing and in advance by the Board of Directors. Upon reasonable notice to Owner, the Board shall be permitted access to the Unit to confirm compliance. Should it be determined in the sole discretion of the Board that the Washer and/or Dryer are no longer "quiet", the Owner may be requested by the Board to change or update the non-compliant product at the Owner's sole cost and expense.

3. Article VII of the Declaration is hereby amended by adding the following as (new) Section 7.11(r)

(r) Smoking. As of the Recording Date of this Amendment, smoking shall be prohibited in any portion of the Property, including all Common Elements, Limited Common Elements, and in the individual Units. The term "smoking" means inhaling, exhaling, breathing or carrying any lighted cigar, cigarette, e-cigarette, marijuana, tobacco product, or similar lighted product in any manner or in any form.

(i) The consumption of cannabis by any means other than smoking is prohibited on the Common Elements; provided that notwithstanding the foregoing, the lawful consumption of cannabis by any means other than smoking is permitted in the Units and on the Limited Common Elements.

(ii) Any Unit Owner may use medically prescribed marijuana in their Unit upon submission of reasonable proof of said prescription to the Board of Directors, subject to any reasonable conditions prescribed by the Board.

(iii) Any Unit Owner in violation of this Amendment or any Unit Owner found to be in violation of the Rules and Regulations adopted by the Board may be subject to a flat or daily fine to be determined by the Board upon notice and an opportunity to be heard. Each day a complaint is received by the Board of Directors/Management that smoke is emanating from inside a Unit or Limited Common Elements into the Common Elements or other Units, shall be

reasonable fine as determined by the Board of Directors. Said Unit Owner shall also be subject to equitable relief in an action brought by the Board of Directors.

(iv) In addition to the authority to levy fines against the Unit Owner for violation of this Amendment or any other provision of the Declaration, By-Laws or Rules and Regulations, the Board shall have all rights and remedies, including but not limited to the right to maintain an action for possession against the Unit Owner and/or their tenant, under 735 ILCS 5/9-111, an action for injunctive and other equitable relief, or an action at law for damages.

(v) Any action brought on behalf of the Association and/or the Board to enforce this Amendment shall subject the Unit Owner to the payment of all costs and attorneys' fees at the time they are incurred by the Association.

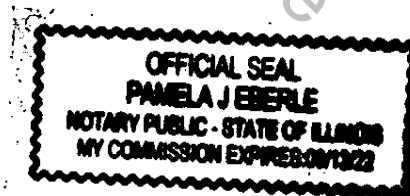
(vi) All unpaid charges as a result of the foregoing shall be deemed to be a lien against the Unit and collectible as any other unpaid regular or special assessment, including late fees and interest on the unpaid balance.

- 4. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- 5. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
