LEGAL DESCRIPTION OF LAND

THAT PART IN BLOCK 9 IN THE ASSESSOR'S DIVISION OF THAT PART EAST OF THE CHICAGO RIVER OF THE EAST HALF OF THE NORTHWEST QUARTER OF SECTION 9, TOWNSHIP 39 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTH EASTERLY CORNER OF SAID BLOCK 9 AND RUNNING THENCE SOUTHEASTWARDLY ALONG THE NORTHEASTERLY LINE OF SAID BLOCK 9 A DISTANCE OF 193.73 FEET THENCE SOUTHMESTWARDLY PERPENDICULAR TO THE LAST DESCRIBED COURSE, A DISTANCE OF 220.05 FEET TO A POINT ON THE EASTERLY DOCK LINE THE NORTH SRANCH OF THE CHICAGO RIVER AS ESTABLISHED BY ORDINANCE OF DECEMBER 4, 1854; "NENCE NORTHWESTWARDLY ALONG SAID DOCK LINE TO AN ANGLE POINT IN SAID DOCK LINE; THENCE NORTHWESTWARDLY ALONG SAID DOCK LINE WHICH LINE FORMS AN ANGLE OF 6 DECREES TO THE RIGHT WITH A PROLONGATION OF THE LAST DESCRIBED COURSE, A DISTANCE OF 89.20 FEET TO A POINT ON THE NORTH LINE OF SAID BLOCK 9, AND THENCE EAST ALO IG THE NORTH LINE OF SAID BLOCK 9, AND THENCE FAST ALO IG THE NORTH LINE OF SAID BLOCK 9.
