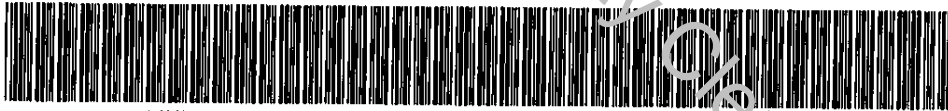



The maturity date of the loan is hereby extended to July 15, 2020. All other terms and conditions of the loan documents shall remain in full force and effect.



Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.


