This matter having come before this Court on the Plaintiffs' (TRUST COMPANY OF ILLINOIS, as successor trustee of the Alice J. Ruzicka 2010 Trust dated June 30, 2010, as amended, and MARQUETTE BANK, as trustee of Trust No. 81-9-5) Motion for Summary Judgment and Plaintiffs' Motion to Dismiss TCF FINANCIAL CORPORATION pursuant to Stipulation, due notice having been given to all parties not previously found to be in default, and the Court being fully advised in the premises,

IT IS HEREBY ORDERED the motions are GRANTED with the following findings:

1. The Security Assignment purportedly executed by James Ruzicka and Alice Ruzicka (the "Ruzickas") on or about October 30, 1981 and purportedly made to The Lawndale Trust and Savings Bank securing a \$120,000 loan to the subject real estate commonly known as 370 Uvedale Road, Riverside, Illinois 60546 (PIN: 15-25-310-070-0000) (hereafter the "Property") is invalid and is stricken of record. - 6. Pursuant to Stipulation, TCF NATIONAL BANK has no legally cognizable interest in the Property;
- 7. Pursuant to Stipulation, TCF Financial Corporation has no legally cognizable interest
