### TERMINATION OF MEMORANDUM OF LEASE

THIS TERMINATION MEMORANDUM OF LEASE (this "Termination"), dated effective as of September 1, 2020 (the "Effective Date"), by and among HRHC DELAWARE, LLC, a Delaware limited liability company ("Landle, d") and HRH CHICAGO, LLC, an Illinois limited liability company ("Tenant").

### **RECITALS**

Landlord and Tenant were parties to that certain Lease dated October 25, 2001, as amended by that certain First Amendment to Lease dated as of February 23, 2005, and as subsequently assigned to Landlord pursuant to that certain Bill of Sale, Assignment of Lease and Security Deposit, and General Assignment dated as of June \_\_\_, 2007 [sic.] collectively, the "Lease"), as evidenced by that certain Memorandum of Lease between Landlord and Tenant, dated July 27, 2007 and recorded September 18, 2007 as Document No. 0725109044 (the "Memorandum of Lease"), for real property legally described on Exhibit A attached hereto, being located at 230 Michigan Avenue, Chicago, Illinois (the "Property").

Landlord and Tenant previously terminated the Lease and now desire to memorialize the termination of the Memorandum of Lease, as more fully described below.

NOW THEREFORE, in consideration of the foregoing, the mutual covenants contained SC herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Termination of Lease Memorandum</u>. The Lease was terminated effective as of September 7, 2017 (the "<u>Lease Termination Date</u>"), and the parties hereby agree that the Memorandum of Lease is terminated.
- 2. <u>No Other Agreement, Possession</u>. There is no other agreement between the Landlord and Tenant granting Tenant the right to use or occupy the Property. Tenant surrendered possession of the Property to Landlord as of the Lease Termination Date, and has not been in possession of the Property since said date.
