MEMORANDUM OF ROOFTOP LEASE

BE IT KNOWN, that Algonquin Venture Real Estate, LLC, an Illinois limited liability company, with a mailing address of 1420 Techny Road, Northbrook, Illinois 60062 ("Owner") and Crown Castle AS LLC, a Delaware limited liability company, with a mailing address of 2000 Corporate Drive, Canonsburg, Pennsylvania 15317-8564 ("Crown") have entered into a Rooftop Lease (the "Agreement") covering a portion of the rooftop of the building (the "Leased Premises") located at 1135 W.
