- As of November 1st, 2020 , the amount payable under the Note and the Security Instrument , consisting of the unpaid amount(s) loaned to (the "Unpaid Principal Balance") is U.S \$ 158,992.57 Borrower by Lender plus any interest and other amounts capitalized.
- Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 3.500 %, from . Borrower promises to make monthly payments of principal and interest of October 1st, 2020 , 2020 , and continuing thereafter on , beginning on the 1st dry of November U.S. \$ 713.95 the same day of each succeeding month until principal and interest are paid in full. The yearly rate of 3.500 will remain in effect until principal and interest are paid ir full. - (c) Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Nove of Security Instrument.
- (d) All costs and expenses incurred by Lender in connection with this Agreement, including recording fees, title examination, and art racy's fees, shall be paid by the Borrower and shall be secured by the Security Instrument, unless stipulated of he wise by Lender.
- (c) Borrower agre is to make and execute such other documents or papers as may be necessary or required to effectuate the terms and conditions of this Agreement which, if approved and accepted by Lender, shall bind and inure to the heirs, executors, a'ministrators, and assigns of the Borrower.
- (f) Borrower authorizes Lenier, and Lender's successors and assigns, to share Borrower information including, but not limited to (i) name, address, and telephone number, (ii) Social Security Number, (iii) credit score, (iv) income, (v) payment history, (vi) account burness and activity, including information about any modification or foreclosure relief programs, with Third Parties the can assist Lender and Borrower in obtaining a foreclosure prevention alternative, or otherwise provide support services related to Borrower's loan. Lender may revoke the waiver as to any or all Escrow Items at any time by a notice given in accordance with the Loan Documents, and, upon such revocation, Borrower shall pay to Lender all Funds, and in such amounts, that are then required under this paragraph.

Lender may, at any time, collect and hold Funds in an amount (a) sufficient to permit Lender to apply the Funds at the time specified under the Real Estate Settlement Procedures Act ("RESPA"), and (b) not to exceed the maximum amount a lender can require under RESPA. Lender shall estimate the amount of Funds due on the basis of current data and reasonable estimates of expenditures of future Escrow Items or otherwise in accordance with applicable law.
