- 2. On or about 10/2/18 Claimant and Arthur & Meghan Miller entered into that certain agreement (the "Contract") for the performance of: Tear out and bag wet drywall (cat 3) HEPA Vacuum. Clean stud wall. Apply plant based anti-microbial agent to more than floor. Install negative air fan, large air scrubber, and dehumidifier. Remove casing. Clean floor. R&R Batt insulation. Seal/prime then paint walls and ceiling. Mask and prep for paint. Protect flooring (heavy paper and tape). R&R recessed light fixture. Paint crown molding. Mask and cover large light fixture. R&R modified bitumen roof. R&R insulation, flash parapet, roof drain, cap flashing, and sheathing. Delivery of rental equipment. R&Albor to install joist. Protect contents. Move and reset contents. Final construction cleaning. General demolition. Remove blown-in cellulose insulation. R&R upstaled insulation. Provide stretch film/wrap, furniture lightweight blanket containment barrier and peel & seal zipper for consumable items. Move back items etc. for the sum of: three hundred sixty-nine thousand, four hundred ninety dollars and (4/100 cents (\$369,490.64).
