Unless the open and vacant building located at or on the above described Property is demolished, repaired, or enclosed, and unless any and all garbage, debris, and other hazardous, noxious, or unhealthy substances or materials are removed from the Property by the owner or owners of record, the beneficial owner or owners of any land trust having title to the Property, or any lien-holder or lienholders of record, within thirty (30) days following the date of this Notice, so that an immediate and continuing hazard to the surrounding community and to the public at large no longer exists, the building shall be demolished, repaired, or enclosed, and any garbage, debris, or other hazardous, noxious, or unhealthy substances or materials shall be removed by the City of Calumet City. Any and all costs and expenses incurred by the City of Calumet City in relation to said demolition, repair, and/or clean-up shall constitute a lien against the property.
