Beginning with the first Change Date, my adjustable interest rate will be based on an Index that is calculated and provided to the general public by an administrator (the "Administrator"). The "Index" is a penchmark, known as the one-year U.S. dollar (USD) LIBOR index. The Index currently published in, or on the website of, The Wall Street Journal. The most recent Index value available as of the date 45 days before each Change Date is called the "Current Index," provided that if the Current Index is less than zero, then the Current Index will be deemed to be zero for purposes of calculating my interest rate.

The notice will include the amount of my monthly payment, any information required by law to be given to me and also the title and talephone number of a person who will answer any question I may have regarding the notice.
