## MORTGAGE AND SECURITY AGREEMENT - 613 NORTH WELLS STREET, LLC

THIS MORTGAGE AND SECURITY AGREEMENT ("Mortgage") is made as of December 18, 2020, by 613 NORTH WELLS STREET, LLC ("Mortgagor"), with a mailing address at 301 N. Canon Drive, Beverly Hills, CA 90210 in favor of BCL-CRE 3 LLC (hereinafter referred to as "Mortgagee") with a mailing address of 450 Skokie Blvd., Bldg. 600, Northbrook, Illinois 60062, and pertains to the real estate described in Exhibit "A", attached hereto and made a part hereof.

#### I, RECITALS

- 1.01 Note. Pursuant to that certain Loan and Security Agreement dated the date of this Mortgage entered into by and between Mortgagee and Mortgagor (said Loan and Security Agreement, as may be amended or restated from time to time, shall be hereinafter referred to as the "Loan Agreement"), that certain note (said note, as may from time to time be amended, modified, substituted, restated, renewed and/or extended, shall hereinafter be referred to as the "Note") in the principal amount of \$5,000,000.00, payable, atting with interest, as specified in the Note, has been or is being contemporaneously executed and delivered by Mortgagor to Mortgagee.
- This Mortgage. To induce Mortgage to (A) enter into the Loan Agreement and (B) make the loan which is the subject of the Note, and as security for the repayment of the Note and payment and performance of all other indebtedness, obligations and liabilities of Mortgagor to Mortgagee, howsoever created, arising or evidenced, and whether now existing or hereafter arising, under the Loan Agreement and any document enterrulinto or given pursuant to the Loan Agreement (all of the indebtedness, liabilities and obligations referenced in this section shall be collectively referred to as the "Obligations"). Mortgagor has agreed to execute and deliver to Mortgage ethis Mortgage. This Mortgage is given as equal security for all of the Obligations without preference or priority of any part of the Obligations by reason of priority of time or of the negotiation thereof or otherwise.

#### THE GRANT

2.01 Now, therefore, in order to secure the payment and performance of the Obligations and the covenants and agreements herein contained. Mortgagor does hereby grant, bargain, sell, convey, mortgage and warrant to Mortgagee and its successors and assigns forever the real estate, and all of its estate, right, title and

interest therein, situated in the state and county as more particularly described in Exhibit A attached hereto and made a part hereof (the "Premises"), together with the following described property (the Premises and the following described property being collectively referred to hereinbelow as the "Property"), all of which other Property is hereby pledged primarily on a parity with the Premises and not secondarily:

- (a) All buildings and other improvements of every kind and description now or hereafter erected or placed thereon and all materials intended for construction, reconstruction, alteration and repair of such improvement now or hereafter erected thereon, all of which materials shall be deemed to be included within the Property immediately upon the delivery thereof to the Premises;
  - (b) All right, title, and interest of Mortgagor, including any afteracquired title or reversion, in and to the rights of the ways, streets, avenues, sidewalks, and alleys adjoining the Premises;
  - (c) £a.5 and all of the tenements, hereditaments, easements, appurerances, passages, waters, water courses, riparian rights, other rights, liberties and privileges of the Premises or in any way now of hereafter appertaining thereto, including homestead and any other claim at law or in equity, as well as any after acquired title, franchise or license and the reversions and remainders thereof;
  - (d) All rents, issues, deposit, and profits accruing and to accrue from the Premises and the avails thereof; and
  - All tenant's security deposits, utility deposits and insurance (e) premium rebates to which Mortgago, may be entitled or to which Mortgagor may be holding; all fix ares and personal property now or hereafter owned by Mortgagor and attached to or contained in and used or useful in connection with the Premises or the aforesaid improvements thereon, including, without limitation, any and all air conditioners, intennae, appliances, apparatus, awnings, basins, bathtubs, orners, bookcases, cabinets, carpets, coolers, curtains, dehumidifiers, disposals, doors, drapes, dryers, ducts, dynamos, elevators engines, equipment, fans, fittings, floor coverings, freezers, furnaces, furnishings, furniture, hardware, heaters, humidifiers, incinerators, lighting, machinery, motors, ovens, pipes. plumbing, pumps, radiators, ranges, recreational facilities, refrigerators, screens, security systems, shades, shelving, shipping dock load level, sinks, sprinklers, stokers, stoves, toilets, trash compactor systems, ventilators, wall coverings, washers, wastewater facilities, windows, window coverings, wiring, and all renewals or replacements thereof or articles in substitution therefor, whether or not the same be attached to such improvements, it being intended, agreed and declared that all such property owned by Mortgagor and placed by it on the Premises or used in connection with the operation or maintenance thereof shall, so far as permitted by law, be deemed for the purposes of this Mortgage to be part of the real estate constituting and located on the Premises and covered by

this Mortgage, and as to any of the aforesaid property that is not part of such real estate or does not constitute a "fixture;" as such term is defined in the Uniform Commercial Code as enacted in the state in which the Property is located, this Mortgage shall be deemed to be, as well, a security agreement, under such Uniform Commercial Code for the purpose of creating hereby a security interest in such property, which Mortgagor hereby grants to Mortgagee as "secured party," as such term is defined in such Code.

#### **GENERAL AGREEMENTS**

- 3.01 <u>Principal and Interest.</u> All of the indebtedness evidenced by the Note shall be promptly paid when due at the times and in the manner provided in the Note, the Loan Agreement and this Mortgage.
- 3.02 <u>Property Taxes.</u> Mortgr gor shall pay immediately, when first due and owing, all general taxes, special taxes, special assessments, water charges, sewer charges and any other charges that may be asserted against the Property or any part thereof or interes therein, and shall furnish to Mortgagee, upon Mortgagee's request, duplicate receipts therefor within 30 days after pay ment thereof. Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any such taxes or assessments, provided that:
  - (a) such contest shall have the effect of preventing the collection of the tax or assessment so contested and the sale or forfeiture of the Property or any part thereof or interest therein to satisfy the same; and
  - (b) Mortgagor has notified Mortgagee in writing of me intention of Mortgagor to contest the same before any tax or assessment has been increased by any interest, penalties or costs.
- Tax Payments by Mortgagee. Upon the occurrence and during the continuance of a Default, 3.03 Mortgagee is hereby authorized upon 10 days notice to Mortgagor (or such lesser notice, including no notice, as is reasonable under the circumstances) to make or advance, in the place and stead of Mortgagor, any payment not paid when due relating to (A) taxes, assessments, water and sewer charges, and other governmental charges, fines, impositions or liens that may be asserted against the Property, or any part thereof, and may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy thereof or into the validity of any tax, assessment, lien, sale, forfeiture or title or claim relating thereto; or (B) any experient or threatened adverse title, lien, statement of lien, encumbrance, claim, charge or payment otherwise relating to any other purpose herein and hereby authorized, but not enumerated in this Paragraph 3.03, whenever, in its judgment and discretion, such advance seems necessary or desirable to protect the full security intended to be created by this Mortgage. In connection with any such advance, Mortgagee is further authorized, at its option, to obtain a continuation report of title or title insurance policy prepared by a title insurance company of Mortgagee's choosing. All such advances and indebtedness authorized by this Paragraph 3.03 shall constitute additional indebtedness secured hereby and shall become immediately due and payable by Mortgagor to Mortgagee without notice with interest at the highest rate specified in the Note.

#### 3.04 Insurance

(a) Hazard. Mortgagor shall keep the improvements now existing or hereafter erected on the Premises insured under a replacement cost form of insurance policy-against-loss-or-damage-resulting-from fire, windstorm and other hazards as may be reasonably required by Mortgagee (including, but not limited to, flood insurance in an amount necessary to comply with applicable law), and to pay promptly, when due, any premiums on such insurance. Without limitation of the immediately preceding sentence, during construction of any improvements on the Premises, Mortgagor shall maintain "Builders Risk" insurance with extended coverage over fire and other casualties using completed values for the amount of the full insurable value for all such improvements under construction at any time on the Premises, including equipment and materials delivered to the Premises for incorporation into the Property. "All such insurance shall be in form and of content, and shall be carried in companies, approved in writing by Mortgagee, and all such policies and renewals thereof (or certificates evidencing the same), marked "paid," shall be delivered to Mortgagee at least 30 days before the expiration of then existing policies and shall have attached thereto standard non-contributing mortgage clauses entitling Mortgagee, as its interest may appear, to collect any and all proceeds payable under such insurance, as well as standard waiver of subrogation endorsements, so long as such subrogation endorsement can be obtained without additional cost to Mortgagor. Mor gar or shall not carry any separate insurance on such improvements concurrent in kind or form with any insurance requi ed hereunder or contributing in the event of loss. In the event of a change in ownership or of occupancy of the Prem see approved in writing by Mortgagee, immediate notice thereof by messenger, facsimile or overnight delivery shall be delivered to all such insurers. In the event of any casualty loss, Mortgagor shall give immediate notice to Mortgage: Losses under any of the aforesaid insurance shall be adjusted and compromised as follows: (A) Mortgagor shall adjust and compromise any such losses up to \$100,000.00 under the aforesaid insurance; and (B) Mortgagor shall all est and compromise any such losses of \$100,000.00 and above under any of the aforesaid insurance with the prior writer approval of Mortgagee not to be unreasonably withheld or delayed; provided, however, that if (i) Mortgagor fails to diligently prosecute the adjustment of any loss and/or (ii) a Default has occurred and is continuing, then Mortgagor hereby permits Mortgagee, at Mortgagee's option, to solely adjust and compromise any such loss, whether above obelow \$100,000.00. Mortgagee shall, after deducting any of Mortgagee's reasonable costs of collection, use, apoly, or disburse the balance of such insurance proceeds (i) toward repairing, restoring and rebuilding the aforesaid imprevements, provided such repair, restoration or rebuilding is economically feasible and the security of this Mortgage is not thereby impaired, in which event Mortgagee shall not be obliged to see to the proper application thereof nor shall the amount so released for such purposes be deemed a payment on the indebtedness secured thereby; or (ii) as a creat upon any portion of the indebtedness secured hereby, with the excess, if any, paid to Mortgagor; provided, however and so long as no Default shall then exist and no Default shall exist at any time during the period of any repair, restoration and/or rebuilding of the aforesaid improvements, and subject to the provisions of the immediately following paragraph, upon Mortgagor's written request to Mortgagee made on or before the disbursement of such insurance proceeds to Mortgagee, such insurance proceeds shall be used to repair, restore and/or rebuild the aforesaid improvements. Unless Mortgagor and Mortgagee otherwise agree in writing, any such application of proceeds to the sums secure's by this Mortgage shall not extend or postpone the due date of any portion of the indebtedness secured hereby or change the amount of any installment due on such indebtedness.

To the extent any such insurance proceeds or any condemnation or eminent domain avards described in Section 3.05 below are used toward repairing, restoring and rebuilding such improvements, such proceeds or awards shall be made available, from time to time, upon Mortgagee being furnished with satisfactory evidence of the estimated cost of such repairs, restoration and rebuilding and with such architect's certificates, waive, soff lien, certificates, contractors' sworn statements and other evidence of the estimated cost thereof and of payments as Mortgagee may reasonably require and approve, and if the estimated cost of the work exceeds 10% of the original principal amount of the indebtedness secured hereby, with all plans and specifications for such plans, restoration and rebuilding as Mortgagee may reasonably require and approve. Payments made prior to the final completion of the work shall not exceed 90% of the value of the work performed, from time to time, and at all times the undisbursed balance of such proceeds or awards remaining in the hands of Mortgagee shall be at least sufficient to pay for the cost of completion of the work, free and clear of any liens. In the event of foreclosure of this Mortgage or other transfer of title to the Premises in extinguishment of the indebtedness secured hereby, all right, title and interest of Mortgager in and to any such insurance policies then in force, and any claims or proceeds thereunder, shall pass to Mortgagee or any purchaser or grantee thereform. Mortgagee may, at any time thereafter and in its sole discretion, procure and substitute for any and all of such insurance policies, such other policies of insurance, in such amounts,

and carried in such companies, as it may select.

- (b) <u>Liability</u>. Mortgagor shall carry and maintain such comprehensive public liability, contractor's liability and workmen's compensation insurance as may be reasonably required from time to time by Mortgagee in\_form\_and\_of\_content,\_in\_amounts, and\_with companies approved in\_writing\_by Mortgagee; provided, however, that the amounts of liability coverage shall not be less than Two Million and No/100 Dollars (\$2,000,000.00) single limit. Certificates of such insurance, premiums prepaid, shall be deposited with Mortgagee and shall contain provision for 30 days' notice to Mortgagee prior to any cancellation thereof.
- Condemnation and Eminent Domain. Any and all awards heretofore or hereafter made or to be made to the present, or any subsequent, owner of the Property, by any governmental or other lawful authority for the taking, by condemnation or eminent domain, of all or any part of the Premises, any improvement located thereon, or any easement thereon or appurtenance thereof (including any award from the United States government at any time after the allowance of a claim therefor, the ascertainment of the amount thereto, and the issuance of a warrant for payment thereof, are hereby assigned by Mortgagor to Mortgagee, which awards Mortgagee is hereby authorized to collect and receive from the condemnation authorities, and Mortgagee is hereby authorized to give appropriate receipts therefor. Morigor or shall give Mortgagee immediate notice of the actual or threatened commencement of any condemnation or empent iomain proceedings affecting all or any part of the Premises, or any easement thereon or appurtenance thereof (including severance of, consequential damage to, or change in grade of streets), and shall deliver to Mortgagee copies of any and all papers served in connection with any such proceedings. Mortgagor further agrees to make, execute and discharged of any time upon request, free, clear and discharged of any encumbrance of any kind whatsoever, any and all further assignments and other instruments deemed necessary by Mortgagee for the purpose of validly and sufficiently assigning all awards and other compensation heretofore and hereafter made to Mortgagor for any taking, either permanent or temporary, under any such proceeding. Notwithstanding anything else contained in his Section, condemnation or eminent domain awards shall be negotiated as follows: (A) Mortgagor shall negotiat: any such losses up to \$100,000.00; and (B) Mortgagor shall negotiate and agree to the amount of any condemnation or eminent domain award of \$100,000.00 and above with the prior written approval of Mortgagee, not to be unreasonably withheld or delayed; provided, however, that if (a) Mortgagor fails to diligently prosecute any such loss or award and/or (b) a Default has occurred and is continuing, then Mortgagor hereby permits Mortgagee, at Mortgagee's option, to solely negotiate and agree to the amount of such condemnation or eminent domain award whether above or below \$100,000.00.
- Maintenance of Property. No substantial building or othe, in provement on the Premises shall be materially altered, removed or demolished, nor shall any substantial fixture. charges or articles of personal property pledged pursuant to this Mortgage on, in, or about the Premises be severed, renic et, sold or mortgaged, without the prior written consent of Mortgagee, except in the ordinary course of Mortgagor's business, and in the event of the demolition or destruction in whole or in part of any of the fixtures, chattels or articles of personal property covered by this Mortgage, except with the prior written consent of Mortgagee, the same shall be replaced promptly by similar fixtures, chattels and articles of personal property at least equal in quality and condition to those replaced, free from any other security interest therein, encumbrances thereon, or reservation of title the eto Mortgagor shall promptly repair, restore or rebuild any building or other improvement now or hereafter situated or, the Premises that may become damaged or is destroyed. Any such building or other improvement shall be so repaired, restored or rebuilt so as to be of at least equal value and of substantially the same character as prior to such Amage or destruction. Mortgagor further agrees not to permit, commit or suffer any waste, impairment or deterioration of the Property or any part thereof; to keep and maintain the Property in good repair and condition;, to make all necessary and proper replacements thereof and additions thereto so that the Premises and such buildings, other improvement, fixtures, chattels and articles of personal property will, at all times, be in good condition, fit and proper for the respective purposes for which they were originally erected or installed.
- 3.07 <u>Compliance with Laws.</u> Mortgagor shall comply in all material respects with all statutes, ordinances, regulations, rules, orders, decrees and other requirements relating to the Property by any federal, state or local authority; and shall observe and comply with all conditions and requirements necessary to preserve and extend any and all rights, licenses, permits (including, without limitation, zoning variances, special exceptions and non-conforming uses), privileges, franchises and concessions that are applicable to the Property or that have been

granted to or contracted for by Mortgagor in connection with any existing or presently contemplated use of the Property.

- Liens and Transfers. Without Mortgagee's prior written consent, Mortgagor shall neither sell, transfer, convey, assign, hypothecate or otherwise transfer the title to or any beneficial interest in all or any portion of the Property, whether by operation of law, voluntarily, or otherwise, contract to do any of the foregoing, nor create, suffer or permit to be created or filed against the Property or any part thereof hereafter any mortgage lien or other lien on the Property; which is not permitted under the Loan Agreement. Without limiting the generality of the foregoing, any sale, conveyance, assignment, hypothecation or transfer prohibited in the Loan Agreement shall be deemed a sale, conveyance, assignment, hypothecation or other transfer prohibited by the foregoing sentence. Any waiver by Mortgagee of the provisions of this Paragraph 3.08 shall not be deemed to be a waiver of the right of Mortgagee in the future to insist upon strict compliance with the provisions hereof.
- 3.09 <u>Subrogation to Prior Lienholder's Rights</u>. If the proceeds of the indebtedness secured hereby, any part thereof, or any amount paid out or advanced by Mortgagee is used directly or indirectly to pay off, discharge or satisfy in whole of the part, any prior lien or encumbrance upon the Property or any part thereof, then Mortgagee shall be subrogated to the rights of the holder thereof in and to such other lien or encumbrance and any additional security held by such holder, and shall have the benefit of the priority of the same.
- 3.10 Mortgagee's Der in is with Transferee. In the event of the sale or transfer, by operation of law, voluntarily or otherwise, of all or any part of the Property, or of any beneficial interest therein, Mortgagee shall be authorized and empowered to deal with the vendee or transferee with regard to (a) the Property or any beneficial interest therein; (b) the indebtedness secured beneficial interest therein; (b) the indebtedness secured beneficial interest therein; (b) the indebtedness secured beneficial interest therein; (c) any of the terms or conditions hereof as fully and to the same extent as it might with Mortgagor, without in any way releasing or discharging Mortgagor from its covenants hereunder.
- 3.11 <u>Stamp Taxes</u>. If at any time the United States government, or any federal, state, county or municipal governmental subdivision, requires or imposes the nal Revenue or other documentary stamps, levies, or any tax on this Mortgage or on the Obligations, then, Mortgagor shall pay for the same with interest and penalties thereon, if any.
- 3.12 Change in Laws. In the event of the enactment, after the date of this Mortgage, of any law of the state in which the Premises are located imposing upon Mortgagee the payment of all or any part of the taxes, assessments, charges, or liens hereby required to be paid by Mortgagor, or charging in any ways the laws relating to the taxation of mortgages or debts secured by mortgages or Mortgagor's interest in the Property, or the manner of collection of taxes, so as to affect this Mortgage or the indebtedness secured hereby or the holder thereof, then Mortgagor, upon demand by Mortgagee, shall pay such taxes, assessments, charges or lens or reimburse Mortgagee therefor; provided, however, that if, in the reasonable good faith opinion of counsel for Mortgagee, it might be unlawful to require Mortgagor to make such payment or the making of such payment might r sult in the imposition of interest beyond the maximum amount permitted by law, then Mortgagee may elect, by notice in verting given to Mortgagor, to declare all of the indebtedness secured hereby to become due and payable within 60 days after the giving of such notice; provided, further, that nothing contained in this Paragraph shall be construed as obligating Mortgagor to pay any portion of Mortgagee's federal, state or local income tax.
- 3.13 <u>Inspection of Property.</u> Mortgagor shall permit Mortgagee and its representatives and agents to inspect the Property from time to time during normal business hours and as frequently as Mortgagee considers reasonable.
- 3.14 <u>Environmental Conditions.</u> Mortgagor hereby represents and warrants to Mortgagee that to the best of Mortgagor's knowledge no hazardous or toxic substances, within the meaning of any applicable statute or regulation, whether federal, state or local, are presently stored or otherwise located on the Property and on any adjacent parcels of real estate, except in accordance with all applicable laws, regulations and rules.

Mortgagor covenants and agrees that all hazardous and toxic substances within the definition of any ap-

plicable statute, regulation or rule (whether federal, state or local), which may be used by any person for any purpose upon the Property, shall be used or stored-thereon-only-in a safe, approved manner, in accordance with all industrial standards and all laws, regulations, and requirements for such storage promulgated by any governmental authority, that the Property will not be used for the principal purpose of storing such substances, and that no such storage, or use will otherwise be allowed on the Property which cause or which will increase the likelihood of causing the release of such substances onto the Property. Upon the written request of Mortgagee to Mortgagor, Mortgagee, its attorneys, employees, agents or other persons or entities designated by Mortgagee shall, from time to time, and at any time, be allowed to enter upon the Property and conduct environmental examinations and environmental audits of the Property, all in form, manner and type as Mortgagee may then require in its reasonable discretion; provided, however, that Mortgagor shall not be responsible for the cost of more than one such examination or audit after the date hereof and prior to the occurrence and during the continuance of a Default, unless Mortgagee shall have cause for additional such examinations. Mortgagor shall fully cooperate and make the Property available to Mortgagee at such times as Mortgagee may reasonably request in order to conduct such environmental examinations and environmental audits.

Mortgage, he elv agrees to give immediate notice of any violation of any federal, state or local statute, rule or regulation dealing viii, the presence or suspected presence of any hazardous or toxic substances or conditions affecting the Property. Mor'gegor covenants and agrees to promptly contain and clean up any and all releases of hazardous substances on the Property in violation of applicable law. Notwithstanding any language or provision of this Mortgage to the contrary, Mortgagor hereby unconditionally gives the Mortgagee the right, but not the obligation, and Mortgagee does not so obligate itself, to undertake to contain and clean up releases of hazardous substances on the Property in violation of applicable law if Mortgagor fails to promptly commence the same after written notice from Mortgager or Mortgager fails to diligently proceed with the same. Mortgagor hereby indemnifies and saves Mortgagee harmless of and from any and all loss, costs (including reasonable attorneys' fees), liability and damage whatsoever incurred by Mortgagee, by reason of any violation of any applicable statute, rule or regulation for the protection of the environment which occurs upon the Property or by reason of the imposition of any governmental lien for the recovery of environment il clean-up costs related to the Property expended by reason of such violation; provided that, to the extent that Mortgarce is strictly liable under any such statute. Mortgagor's obligation to Mortgagee under this indemnity shall likewise be without regard to fault on the part of Mortgagor with respect to the violation of law which results in liability to the viortgagee. Mortgagor further agrees that this indemnity shall continue and remain in full force and effect beyond the term of the indebtedness or obligation which is secured by this Mortgage and shall be terminated only when there is no further obligation of any kind whether in law or in equity or otherwise of Mortgagee in connection with any such environmental clean-up costs, environmental liens, or environmental matters involving the Property. Notwithstanding the foregoing, in no event shall Mortgagee have any liability to mortgagee for environmental conditions a ving (A) after it ceases to have possession of the Property due to the exercise by Mortgagee of its remedies hereinder or (B) from the gross negligence or willful misconduct of Mortgagee

- 3.15 Acknowledgment of Debt. Upon Mortgagee's request, Mortgagor shall furrish thom time to time, a written statement, duly acknowledged, specifying the amount due under the Note and this Mortgage and disclosing whether any alleged offsets or defenses exist against the indebtedness secured hereby.
- 3.16 <u>Other Amounts Secured.</u> At all times, this Mortgage secures in addition to the Note 2ry other amounts as provided herein; <u>provided, however,</u> that in no event shall the aggregate indebtedness secured by this Mortgage exceed 3 times the original principal amount of the Note.
- 3.17 Assignments of Rents and Leases. Mortgagor hereby assigns, transfers and sets over unto Mortgagee all the rents, fees or payments now or hereafter due, under or by virtue of any lease, either oral or written, or any letting of, or any agreement for the use or occupancy of any part of the Property, whether heretofore, now or hereafter agreed to ("Rents") and all leases and modifications thereof, now existing or hereafter made relating to the Property ("Leases"); together with the right to let and relet the Property or any part thereof, in Mortgagee's sole discretion, and to do anything with respect to the Property as Mortgagor might do. - 3.19 Security Instruments.
