## RECEIVER'S DEED

THIS INDENTURE, made this 4th day of MARCH, 1971,  
 between FEDERAL SAVINGS AND LOAN INSURANCE CORPORATION, an agency  
 of the United States Government, as Receiver for Apollo Savings,  
 pursuant to an Order made by Justin Hulman, Commissioner of Sav-  
 ings and Loan Associations of Illinois, dated the 30th day of  
 September, 1968, effective October 1, 1968, Grantor, and GENARO G.  
 ESCAMILLA and BERTHA D. ESCAMILLA, HIS WIFE, AND FELIPE HERNANDEZ  
 and HORTENCIA HERNANDEZ, HIS WIFE.

WITNESSETH THAT:

The Grantor, in consideration of the sum of Eleven Thousand  
 Two Hundred Forty-eight and 83/100 Dollars (\$11,248.83), receipt  
 whereof is hereby acknowledged, pursuant to an Order of the Cir-  
 cuit Court of Cook County, Illinois, entered in case No. 68 CH  
 1887, on the 18th day of February, 1971, and in pursuance of the  
 power and authority vested in the Grantor as said Receiver and  
 of every other power and authority the Grantor hereunto enabling,  
 does hereby convey and quitclaim unto the Grantees in joint  
 ancy and not in tenancy in common all Grantor's interest in  
 following described real estate, situated in the County of Co  
 and State of Illinois, to wit:

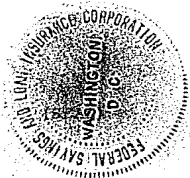
Lot 37 in Block 1 in Thomas Kelly's Addition to Chicago
