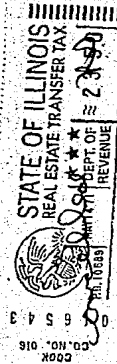

Third Principal Meridian, in Cook County, Illinois.



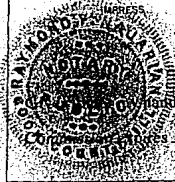
