 and remaining unreleased at the date of the delivery hereof.

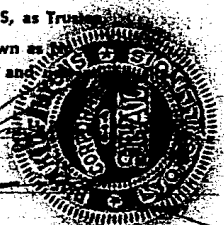

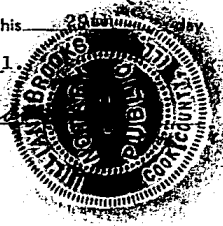
