- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanics liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complet within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.

- 7. When the indebtedness hereb sourced shall become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Tri tee's all have the right to foreclose the lien hereof and also shall have all other rights provided by the laws of Illinois for the enforcement of a 1 ort of 1 cet. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expend ures and expenses which may be paid or incurred by or on behalf of Trustee or holders of the note for attorneys' fees, Trustee's fees, appraiser's lees, outland for the decree of procuring all such abstracts of title, title searches and examinations, guarantee policies, Torrens certificates, a d simil r data and assurances with respect to title as Trustee or holders of the note may deem to be reasonably necessary either to prosecute suc suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. In addition, all expenditures and expenses of the nature in this paragraph mentioned shall become so much additional indebtedness secured hereb and mmediately due and payable, with interest thereon at the rate of seven per cent per annum, when paid or incurred by Trustee or holders if the note in connection with (a) any action, suit or proceeding, including but not limited to probate and bankruptey proceedings, to which either. It is all be a party, either as planinf, claimant or defendant, by reason of this Trust Deed or any indebtedness hereby secured; or (b) preparations for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclose whether or not actually commenced; or "c" or "cradions for the defense of any threatened suit or proceeding which might affect the premises of the security hereof, whether or not actually commenced.

- 10. No action for the enforcement of the lien of this Trust Deed or of any provision hereof shall the subject to any defense which would not good and available to the party interposing same in an action at law upon the note hereby secured.

- - 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have

been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.
