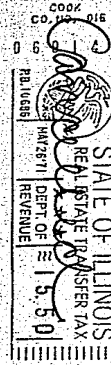

To Have and to Hold the same unto said party of the second part forever.



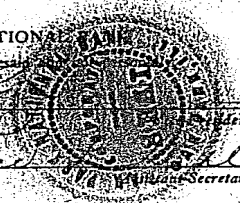
subject to all General Taxes and Special Assessments of record, whether current, forfeited, sold or otherwise, and zoning and building ordinances.

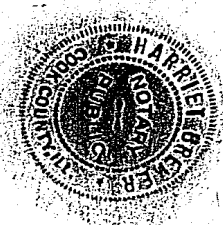
