SUBJECT TO: Restrictions and conditions of record.

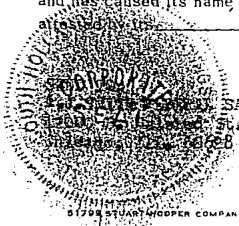
