not as tenants in common, but as joint tenants of Cook County, Illinois, parties of the second part.

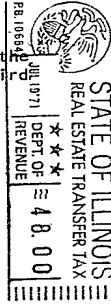
Witnesseth, That said party of the first part, in consideration of the sum of Ten and No/100-

SUBJECT TO: Restrictions and conditions of record

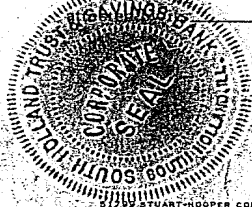
