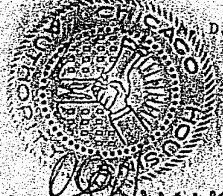


NO TAXABLE CONSIDERATION

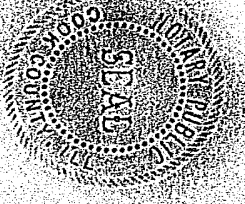
