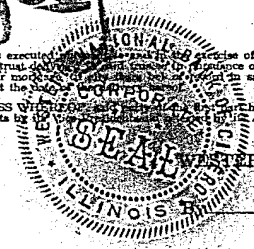
That part of the Northeast quarter of Section 2, Township 38 North, Range 12, East of the 1rd Principal Meridian, described as follows: Beginning at a point on the West line of JOLIET ROAD, 33 feet West and 108 feet South of the Northeast corner of said Section 2; thence South of the West line of JOLIET ROAD, and 33 feet West and parallel to the East line of said Section 2, 318.03 feet more or less to the Northerly line of OGDEN AVENUE; thence Southwesterly on the Northerly line of OGDEN AVENUE, 125 feet to the Easterly line of the premises conveyed to JOSEPH J. JANDA and AGNES JANDA by Deed dated June 1st, 1948 and recorded June 8th, 1948 as Document 14331883; thence North 307.92 feet more or less on the East line of said premises conveyed to JOSEPH J. JANDA and AGNES JANDA aforesaid to a point on the South line of BARRY POINT ROAD as now occupied; thence Northeasterly on the Southerly line of BARRY POINT ROAD 123.43 feet more or less to the Westerly line of JOLIET ROAD; thence Southeasterly along the Westerly line of JOLIET ROAD, 83.28 feet more or less to the place of beginning, in Cook County, Illinois.
