THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanics liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note: (5) complet within a reasonable time any building or buildings now or at any time in process of erection upon said premises: (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the cost, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior er un brances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or tille or claim thereof, or redern from units aside or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all exploses paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the other of the protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which act in her in authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable with at notice and with interest thereon at the rate of seven per cent per annum. Intention of Trustee or holders of the note shall never be considered as a wiver of any right accruing to them on account of any default hereunder, on the part of Mortgagors.
- 5. The Truese or the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any out and ement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the accuracy of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagors shall p₁ cac² item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the election of the holders of the principal note, and without notice to Mortgagors, all uppaid indebtedness secured by this Trust Deed shall notwithstanding anything in th pri-cipal note or in this Trust Deed to the contrary, become due and payable when default shall occur in payment of principal or interest, or in case fault shall occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.

 7. When the indebtedness hereby cour d.s. Il become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Trustee. "at b a e the right to foreclose the lien hereof and also shall have all other rights provided by the laws of Illinois for the enforcement of a mortgage debt. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures an exp ness which may be paid or incurred by or on behalf of Trustee or holders of the note for attorneys fees, Trustee's fees, appraiser's fees, out ays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expend a father entry of the decree) of procuring all such abstracts of itile, title scarches and examinations, guarantee policies. Torrens certificates, and saminar uar and assurances with respect to title as Trustee or holders of the note may deem to be reasonably necessary either to prosecute such suit or o evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on accordal costs and expenses incident to the foreclosure proceedings, including all stable it ms as are mentioned in the preceding paragraph hereof; ond, all other items which under the terms hereof constitute secured indebtedn ss and items that evidenced by the note hereby secured, interest therefor as herein provided; third, all principal and interest tremaining unpaid fourth, any overplus to Martgagors, their heirs, legal resentatives or assigns as their rights may appear.
- 10. No action for the enforcement of the lien of this Trust Deed or of any provision hereof shall be subject to 2 by occurse which would not be good and available to the party interposing same in an action at law upon the note hereby secured.
- 11. Trustee or the holders of the note shall have the right to inspect the premises at all reasonable times and acc as thereto shall be per-
- 12. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trustee be obligated to record this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions hereunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may require indemnities satisfactory to him before exercising any power herein given.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that a indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purporting to be executed by a prior trustee hereunder or which conforms in substance with the description doed of the principal note and which purports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the Original trustee and he has never executed a certificate on any instrument identifying same as the principal note described herein, he may accept as the genuine principal note herein described any note which may be presented and which burners in substance with the description herein contained of the principal note herein described any note which may be presented and which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as makers thereof.
 - 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have

This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through tgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
