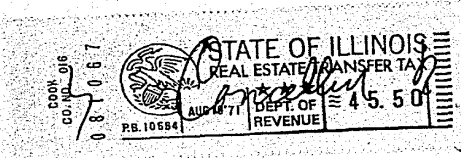
not as tenants in common, but as joint tenants of Cook County, Illinois, parties of the second part.

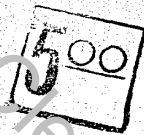

To Have and to Hold the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

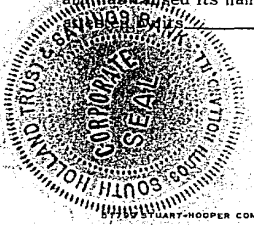


