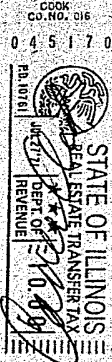
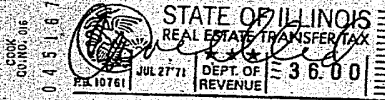

of 6539 South St. Lawrence, Chicago parties of the second part.

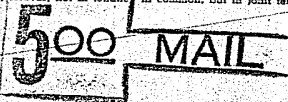
