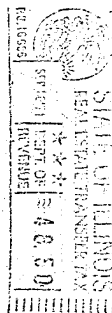
Trustee's Deed Joint Tenancy

SUBJECT TO: Restrictions or conditions of record

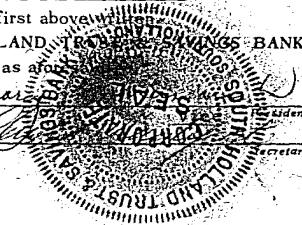
