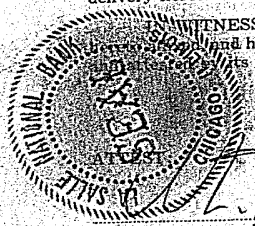

**SUBJECT TO:** All taxes and assessments levied after the year 1971 and all restrictions of record.

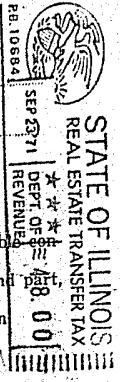

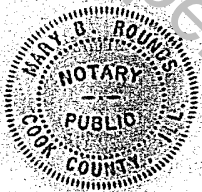
