This Indenture,

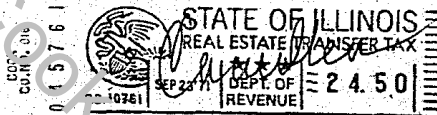

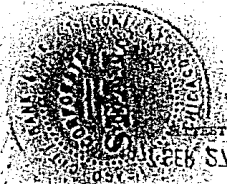

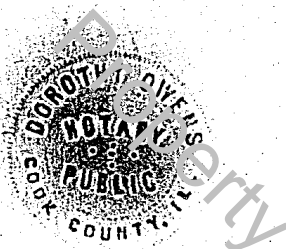
