WILSON, divorced & not since remarried of 5400 Carriage Way Drive, Apt. 205 of the City of Rolling Meadows, County of Cook and State of Illinois, not in tenancy in common, but in joint tenancy, the following described Real Estate, to wit:

Lot No. 141 in Elk Grove Estate Townhouses of Parcel "G", being a Subdivision in the South Half of Section 29, Township 41 North, Range 11, East of the Third Principal Meridian in Cook County, Illinois, according to the plat thereof recorded October 24, 1969, as Document No. 20995531 and filed with the Registrar of Titles on October 24, 1969 as Document LR2477591.

Subject to:

- (1) General taxes for the year 1971 and subsequent years.
- (2) Any special taxes or assessments levied for improvements not yet made.

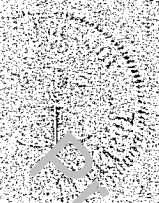
