of Cook County party of the second part.

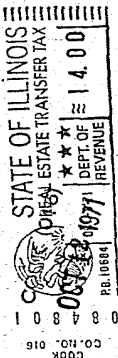
Witnesseth, That said party of the first part, in consideration of the sum of

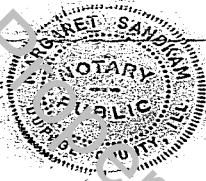
