

EXECUTORS' DEED

This Indenture, Made this 22nd day of July A.D. 1971, between John F. Pilgrim and National Bank of Austin of the City of Chicago in the County of Cook and State of Illinois as executors of the last will and testament of Francis C. Pilgrim, deceased, late of Cook County in the State of Illinois, party of the first part, and Cyrus Serry and Mahindokht Serry, his wife, not as tenants in common but as joint tenants, of the Village of River Forest in the County of Cook and State of Illinois, party of the second part;

Witnesseth, That, whereas Francis C. Pilgrim late of River Forest in the County of Cook and State of Illinois, deceased, in his lifetime made and executed his last will and testament, bearing date the 15th day of August A.D. 1967, and which was thereafter on the 17th day of February A.D. 1970, duly admitted to record in the Circuit court of Cook County in the State of Illinois, whereby, among other things, he constituted and appointed the said John F. Pilgrim and National Bank of Austin executors of his said last will and testament, and did thereby, among other things authorize and empower said executors to sell and convey the real estate herein described: South half of Lot 16 in Block 5 in part of River Forest being a subdivision of part of Section 12, Township 39 North, Range 12 East of the Third Principal Meridian as surveyed for the Suburban Homes Mutual Land Association according to the plat thereof recorded of said subdivision June 23, 1890, in Book 43 of Plats, Page 20 as Document 129153.

AND WHEREAS, on the 17th day of February A.D. 1970 letters-testamentary duly issued out of said Circuit court to the said party of the first part, which said letters are still in full force and effect.

NOW, THEREFORE, The said party of the first part, by virtue of the power and authority to them given in and by the said last will and testament, and of each and every other power and authority hereunto enabling, and for and in consideration of the sum of Six Thousand Five Hundred Dollars, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged; do hereby ALIEN, REMISE, RELEASE and CONVEY unto the said parties of the second part, their heirs and assigns, forever, all that tract or parcel of land, lying and being in the County of Cook and State of Illinois hereinabove described;

TOGETHER, with all and SINGULAR, the hereditaments and appurtenances thereunto belonging, or in any wise appertaining, and all the estate, right, title, interest, claim and demand whatsoever, at law or in equity, which the said Francis C. Pilgrim testator, had at the time of his death or which the said party of the first part now has, in and to the said premises: TO HAVE and TO HOLD the same unto the said party of the second part, their heirs and assigns forever, as fully and effectually to all intents and purposes in law, as they, the said party of the first part might, could or ought to sell and convey the same, by virtue of the said last will and testament above referred to.

In Witness Whereof, the said party of the first part, as executors of the last will and testament of the said Francis C. Pilgrim deceased, have hereunto set their hands and seals, the day and year first written.
